PPB admits the problem themselves ""The current system of arbitration... undermines the chief's ability to hold officers accountable to the high standards of our profession," said PPB Assistant Chief Chris Davis at a recent hearing before Oregon's Senate Judiciary Committee."

The unions and arbitrators use the full justice system against justice

"PPB policy is notably vague when granting officers the right to use deadly force, requiring only that such action is "objectively reasonable." The bureau requires that determination be made "based on the totality of circumstances known by an officer at the time of action or decision-making... without the clarity of 20/20 hindsight after the event has concluded." which opens the door for Union Lawyers and arbitrators to blame the policy and shield the officer.
