Dear Education Subcommittee Chairs and Members,

I am writing in response to the proposed ODE budget cuts that eliminate funding for vision screening in the 2020-2021 school year. As a pediatric eye care professional and member of the ODE Vision Screening Task Force, our research team at Pacific University has been working with the Oregon Lions Sight and Hearing Foundation conducting studies to evaluate the efficacy of the SPOT screening in terms of how well the screening detects the high priority vision conditions. We have also been looking at the relationship between vision screening results and academic achievement using 3rd grade ELA and MATH test results from schools across the state. We have found a clear relationship. Schools with more vision screening failures have lower standardized state test scores, even when controlling for socioeconomic factors such as the percentage of students who qualify for Free or Reduced Lunch. We also looked at individual test scores compared to 3rd grade test scores in the Salem Keizer District and found an even more striking relationship. We are working on publishing these findings but I want to share the summary with you now so you understand how important vision is as a factor affecting learning for our most at risk students. (Please see attached summary). I know this is a really difficult time for all of us who serve students. I just wanted to share this information so you can make well-informed decisions.



# Vision Screening Results and 3<sup>rd</sup> Grade State Test Results in Oregon, 2018 (preliminary findings)

- Pacific University College of Optometry researchers working with Oregon Lions and Oregon Dept. of Education
- Data collected from 3<sup>rd</sup> grade students in Salem/Keizer District who were screened by Oregon Lions Foundation in spring of 2018
- 366 of 2757 (13.2%) of students failed one or more aspects of the vision screening (SPOT photoscreener)
- Looked at 3<sup>rd</sup> grade state test scores: Compared percentile rank of students who passed vs failed the vision screening
- Children who failed the vision screening performed on average 10% lower than those who pass the vision screening on both the English Language Arts and Math tests
- Children with the most significant vision conditions or multiple vision conditions perform about 20% lower than average.

The draft Rebalanced Budget plan includes *eliminating* school vision screenings for the 2020-2021 school year. School vision screenings for Oregon's most vulnerable children are critical to identifying underlying issues that impact their ability to succeed in school. We urge you to continue this essential program and dedicate a reduced portion of the remaining vision screening funds (\$300,000 of the \$800,000 remaining) towards at-risk students. The \$300,000 will be used to target Title 1 schools to address the needs of Oregon's most vulnerable children.

The vision screening process utilizes a no-touch, cutting-edge technology, conforming to all physical and social distancing requirements and will be done using the same precautions that will be used in schools and classrooms. The attached one-pager explains the COVID-19 vision screenings in more detail. Additionally, the short video linked below shows how vision screening can be successfully accomplished adhering to all social distancing and safety measures.

Since 2013, the Oregon Legislature has passed multiple laws and appropriations

mandating vision screening for children and reimbursing schools for the cost of vision screening. This is in recognition of the fact that 25% of children have an undiagnosed vision problem that can significantly impact their ability to succeed in school. Identifying vision issues early and subsequent treatment can dramatically improve student outcomes, including positively impacting Oregon high school graduation rates. Students who can't read at grade level are 13 times less likely to graduate from high school. Eighty percent of learning is visual. Oregon students have already been adversely affected by missing out on important classroom experience. This program cut will further divide students based on their access to healthcare.

The Oregon Lions Sight & Hearing Foundation (OLSHF) has 485 public schools scheduled for vision screening events for 2020-2021, which would amount to approximately 160,000 students screened. We anticipate scheduling more schools for the 2020-21 school year. Moreover, we expect to refer at least 17,000 students to Oregon eyecare providers to get the support that they need. Serving this number of students has required significant investment and reliance on the state funding now in question. Pulling funding now could cause a significant disruption in our ability to serve students and our community now and in the future.

We understand the need for budget reductions statewide, but do not believe this program should be eliminated. Rather, this fund could be reduced to \$300,000 for the current school year. Eliminating funding for school vision screenings this year will make restarting vision screenings post-COVID even more challenging, leaving our most vulnerable students without necessary early intervention. \$300,000 is critical bridge funding for a vital public and school health program. We appreciate your advocacy to preserve as much of the School Vision Screening fund as possible for the 2020-21 school year.

# Adapting school-based vision screenings for Social Distancing

The Oregon Lions Sight & Hearing Foundation (OLSHF) has **over 500 public schools scheduled for vision screening events** for 2020-2021, which represents **almost 200,000 students to be screened**. We anticipate scheduling another 100 schools for the 2020-21 school year. Moreover, we expect to <u>refer at least 20,000 students</u> to Oregon eye care providers to get the support that they need.

During this time of social distancing, OLSHF recognizes the need to adapt our current screening protocols to keep the students, school personnel, and our team safe. The SPOT hand-held screening device we use needs to be three feet from the student's eyes to take the measurements needed to detect vision issues. Our foundation has redesigned our screenings to meet health guidance, including the following:

- OLSHF staff, working in teams of 2-5, will have appropriate personal protective equipment including options of masks, eye wear, face shields, gloves, cleaning wipes, and more.
- Equipment will be disinfected between every event and during events whenever staff exchange equipment.
- We will secure the SPOT device on the front of an adjustable surface (such as an A/V cart with a tripod; supplied by OLSHF). This ensures a minimum 6-foot distance between the student and the screener.
- The student moves into the initial position, then when asked, they provide their ID label by placing it on a clipboard once the team member has moved out of range.





- After the student steps back, staff inputs the student ID and adjusts the SPOT device to align with the student's eyes.
- The **staff member steps back and the student steps forward to be screened**. The SPOT takes the images and digitally records the screening results.

I am a retired elementary and middle school teacher, and spent so very many years working with students with vision impairments that could have been improved or prevented at an early age. My own son had undiscovered amblyopia, and although we found the condition at a fairly early school age his vision was never responsive to treatment as might have been possible earlier and he is functionally blind in one eye.

I do NOT want other kids to experience the same vision challenges as my son or my previous students. Although every child learns in an individual fashion, research shows that approximately 80% of learning at an early age is visual. The ODE School Vision Screening Fund has allowed organizations such as the Oregon Lions Sight and Hearing Foundation (of which I am a past Chair and an active screening volunteer) to vision screen Oregon students in K-5, which helps to identify vision health issues in some of our most vulnerable children. The wide open societal discussion happening currently points out the inequity of education services offered to students of color - and this Vision Screening Fund works to affect exactly that issue!

I understand the need for budget cuts at this time, certainly, but I strongly believe that this program needs and deserves to be continued.
