Q: Why on God's earth is there such a HUGE lead time, when anytime anyone asks about a system update? I've heard that it could take FIVE YEARS...??? REALLY? FIVE YEARS??

RIDICULOUS. I can have a website built, up and running with product, a pay system and marketing in place in less than a week. I can then flood all the social streams in a matter of hours with ads and marketing to drive customers to me in short order.
