I have wrote several letters over the months to OED . concerned news stations , Oregon papers and in the end its still no communication with the OED unless they choose to contact you. Finally I got call mid August and a pleasant sounding gentleman went over my weeks of claims, and at the end said everything was in order and should receive my backlog of claims and any new ones that were to come ,I asked if he could call me back the following week to make sure everything was in order ,he said no problem but he would have to contact me as they don't take personal e-mails or give out names..I said fine ,two days later I received the last four weeks of claims, but nothing since (all information is exactly the same) and on line it said all the rest were pending.Needless to say the gentleman didn't return his promise of a follow-up call and once again , cannot get through on there phone lines and they are not responding to there comment line for help. From what I'm reading online it seems to be the 1099 gig workers and rideshare drivers that are being ignored. Its like they don't feel as if we deserve this help since we don't pay into the overall insurance fund.but it's the government that said we can receive these benefits because of this pandemic I had payed into that unemployment for over 45 years and never took an unemployment claim in all that time .I have been doing rideshare for the last two years because of health reasons and am very concerned of coming into contact with the virus as I am 60 and have lung issues. But with only 4 weeks of pay since early March and maxed out credit cards I'm going to have to go back to driving very soon and run the risk of coming into contact with the virus, with the unemployment this could maybe, be avoided awhile longer , perhaps even to a vaccine , that being said I think there way of conducting themselves is criminals , not just to me, but the many thousands of people that are being ignored also ,Anyway thank you for hearing my story and I hope a resolution is found soon
