STATE BOARD OF TAX PRACTITIONERS

The Governor has appointed the following individuals to the State Board of Tax Practitioners subject to Senate confirmation.¹

Appointees

Mamie Carter of Gresham; Reappointment Rachel Bradley of Hillsboro; New Appointment

Term

Carter: September 26, 2020 – September 25, 2023 Bradley: October 1, 2020 – September 30, 2023

Appointment/Confirmation Authority

ORS 673.725 (2019)

Statement of Economic Interest²

Not required.

Statutory Requirements³

The board consists of seven members appointed by the Governor and subject to confirmation by the Senate.⁴ Of the members of the board, six must be licensed as tax consultants who have been engaged in the preparation of personal income tax returns for another and for a valuable consideration for no less than five years (**BRADLEY**; **CARTER**; CUMPTON; GARDIEPY; LONGWORTH; VETTER). One member of the board must be a member of the general public (PAYNE). Members serve three-year terms, at the pleasure of the Governor, and are eligible for appointment to no more than three terms in office.

Duties and Authority

The board protects Oregon consumers by ensuring tax practitioners are competing and ethical in their professional activities.⁵

The board must:6

- determine qualifications of applicants for licensing as a tax consultant or a tax preparer in this state; cause examinations to be prepared, conducted, and graded; and issue licenses to qualified applicants upon their compliance with the laws administered by the board;
- adopt and assess fees for specified services; and
- formulate a code of professional conduct for tax consultants and tax preparers.

The board may:7

- refuse to issue or renew a tax consultant or preparer's license, suspend, revoke, or restore a tax consultant or preparer's license, or reprimand any licensee;
- investigate alleged violations of the laws administered by the board;
- enforce the laws administered by the board and exercise general supervision over tax consultant and tax preparer practice;
- issue an order directed to a person to cease and desist from any violation or threatened violation of the laws administered by the board;
- assess civil penalties of up to \$5,000 for specified violations;
- assess against the licensee or any other person found guilty of violating any law administered by the board the costs associated with the disciplinary or other action taken by the board;
- order that any person who has engaged in or is engaging in any violation of the laws administered by the board shall offer to rescind and pay restitution to anyone harmed by the violation who seeks rescission;
- adopt rules necessary to carry out the statutes administered by the board; and
- impose the requirement of successful participation and completion of an educational program specified by the board as correction or as a condition to reissuance, restoration, retention or renewal of the license.
