## ELECTRICAL AND ELEVATOR BOARD

The Governor has appointed the following individuals to the Electrical and Elevator Board subject to Senate confirmation.<sup>1</sup>

### Appointees

Amy Beyer of Beaverton; New Appointment  
Elizabeth Bunga of Portland; New Appointment

### Term

Beyer: October 1, 2020 – June 20, 2023  
Bunga: October 1, 2020 – June 20, 2021

### Statement of Economic Interest<sup>2</sup>

Not required.

### Statutory Requirements<sup>3</sup>

The board consists of 15 members appointed by the Governor and subject to confirmation by the Senate, including:<sup>4</sup>

- a fire and casualty underwriter;
- a representative of industrial plants regularly employing licensed electricians;
- a person representing the power and light industry (PALMROSE);
- an electrical equipment supplier who otherwise qualifies by experience in the industry (HALL);
- an elevator manufacturing representative (McNEILL);
- One member from the electrical equipment manufacturing industry who otherwise qualifies by experience and training in electricity (BARLOW);
- two journeyman electricians (FLEGEL, MILLER);
- an electrical inspector (SMITH);

- two electrical contractors (KYLE, RICHARDS);
- a municipal building official (**BUNGA**);
- a journeyman elevator installer (CARMONY);
- an owner or manager of a commercial office building (TOTTEN); and,
- a public member who does not receive compensation from any interest represented on the board (**BEYER**).

Members serve four-year terms and at the pleasure of the Governor. A member may not serve more than two full terms. The board must select one of its members as chairperson and another as vice chairperson, for such terms and with duties and powers necessary for the performance of the functions of such position as the board determines. A majority of the members of a board constitutes a quorum for the transaction of business. The board must meet at least four times per year.<sup>5</sup>

## Duties and Authority

The board assists the Director of the Department of Consumer and Business Services in administering the state electrical and elevator programs.<sup>6</sup> The board must:<sup>7</sup>

- administer and enforce the state's Electrical Safety Law;
- select two members to serve on the Construction Industry Energy Board;
- review amendments to the electrical provisions of the Low-Rise Residential Dwelling Code;
- adopt rules as required to administer the Electrical Safety Law, including rules to administer licensing, certification, registration of regulated persons, and the sale and regulation of electrical permits;
- receive, review, and make determinations on appeals; and
- adopt and administer standards for the delegation of a municipal electrical inspection program.

The board may:<sup>8</sup>

- adopt rules to administer the licensing, certification, or registration of persons regulated by the Electrical Safety Law;
- deny a license, certificate, registration, or application or may suspend, revoke, condition, or refuse to renew a license, certificate, or registration if the board makes specified findings;
- adopt specified exemptions from the license, permit, and product registration requirements of the Electrical Safety Law; and
- impose civil penalties for specified violations.
