FEMA Reimbursement

Request: Establish a \$75,014,016 Other Funds expenditure limitation for the Department of Administrative Services for monies received from the Federal Emergency Management Agency (FEMA) to pay for COVID-19 emergency response activities, including personal protective equipment purchases.

Description: At the beginning of the COVID-19 pandemic, the Department of Administrative Services (DAS) assumed the role of primary purchasing agent for personal protective equipment (PPE) on behalf of the state. This was done to leverage existing procurement staff at DAS, as well as, ensure the state benefited from economies of scale when in the PPE marketplace. DAS has also been responsible for storing and distributing PPE and other emergency supplies to counties and other local partners. In addition, DAS supported efforts to establish an emergency hospital at the Oregon State Fairgrounds and locate the Battelle decontamination system for PPE at the University of Oregon.

To date, DAS has been approved to receive \$75,014,016 from the Federal Emergency Management Agency (FEMA) for expenditures related to the COVID-19 response efforts. DAS will continue to assess and maximize the use of FEMA funding throughout the remainder of the COVID-19 pandemic response period. While FEMA reimbursements are federal revenues, a decision was made to have all FEMA reimbursements run through the state's Office of Emergency Management (OEM). OEM will be requesting Federal Funds expenditure limitation to accommodate transfers to final recipient agencies at a later date, when FEMA reimbursement data is more complete.

Approving the Other Funds expenditure limitation for FEMA reimbursements results in DAS having excess Federal Funds expenditure limitation that had been previously approved to expend Coronavirus Relief Fund (CRF) monies that is now not needed and is available for other uses. Because of this, the Department of Administrative Services does not need additional Federal Funds expenditure limitation to accommodate additional CRF payments requested for agenda items #4, #5, and #6, which will be accessing the CRF now available due to the FEMA reimbursement.

Recommendation: The Co-Chairs of the Emergency Board recommend establishing a \$75,014,016 Other Funds expenditure limitation for the Department of Administrative Services for monies received from the Federal Emergency Management Agency (FEMA) to pay for COVID-19 emergency response activities, including personal protective equipment purchases.

Nature of the Request

DAS requests establishment of an Other Funds expenditure limitation of \$75,014,016 to accept already approved funds from FEMA to pay for emergency response efforts and activities.
