SUMMARY

Establishes office of Superintendent of Public Instruction as statutory office. Takes effect on passage of _____ Joint Resolution ___ (2021) (LC 728) at next regular general election held throughout state. 1 A BILL FOR AN ACT Relating to the Superintendent of Public Instruction; creating new pro-2 visions; amending ORS 171.735, 240.205, 244.050, 326.555, 329.837, 357.021 3 and 458.558; repealing ORS 326.300; and prescribing an effective date. 4 Be It Enacted by the People of the State of Oregon: 5 SECTION 1. ORS 326.300 is repealed and section 2 of this 2021 Act 6 is enacted in lieu thereof. 7 SECTION 2. (1)(a) The Governor shall appoint a Superintendent of 8 Public Instruction, who holds office at the pleasure of the Governor. 9 (b) The appointment of the superintendent is subject to confirma-10 tion by the Senate as provided by ORS 171.562 and 171.565. 11 12 (2) In addition to any duties and powers prescribed by law, the superintendent shall supervise and control the Department of Education. 13 (3) The superintendent shall receive a salary set by the Governor, 14 and shall be reimbursed for all expenses actually and necessarily in-15 curred by the superintendent in the performance of official duties. 16 **SECTION 3.** ORS 171.735 is amended to read: 17 171.735. ORS 171.740 and 171.745 do not apply to the following persons: 18 (1) News media, or their employees or agents, that in the ordinary course 19 of business directly or indirectly urge legislative action but that engage in 20

- 28 240.205. The unclassified service shall comprise:
- 29 (1) One executive officer and one secretary for each board or commission,
- 30 the members of which are elected officers or are appointed by the Governor.

- 2 ernor and each full-time salaried member of a board or commission required
- 3 by law to be appointed by the Governor.

- 22 (3) By April 15 next after the filing deadline for the primary election, 23 each candidate described in subsection (1) of this section shall file with the 24 commission a statement of economic interest as required under ORS 244.060, 25 244.070 and 244.090.
- 26 (4) Not later than the 40th day before the date of the statewide general election, each candidate described in subsection (1) of this section who will appear on the statewide general election ballot and who was not required to file a statement of economic interest under subsections (1) to (3) of this section shall file with the commission a statement of economic interest as required under ORS 244.060, 244.070 and 244.090.

- 1 (5) Subsections (1) to (3) of this section apply only to persons who are incumbent, elected or appointed public officials as of April 15 and to persons who are candidates on April 15.
- (6) If a statement required to be filed under this section has not been received by the commission within five days after the date the statement is due, the commission shall notify the public official or candidate and give the public official or candidate not less than 15 days to comply with the requirements of this section. If the public official or candidate fails to comply by the date set by the commission, the commission may impose a civil penalty as provided in ORS 244.350.

12 326.555. There is established a State Council for Educational Opportunity for Military Children, as described in Article VIII of the Interstate Compact 13 on Educational Opportunity for Military Children under ORS 326.552, con-14 sisting of the [Deputy] Superintendent of Public Instruction, the members of 15 the State Board of Education, the military family education liaison and the 16 compact commissioner. The Governor may appoint other individuals to the 17 state council and shall make a good faith effort to ensure that other indi-18 viduals appointed are individuals who are described in Article VIII of the 19 Interstate Compact on Educational Opportunity for Military Children under 20 ORS 326.552 and who are well informed on the principles of education of 21 military children. 22

329.837. The University of Oregon shall report annually on the implementation, longitudinal progress and results of the Early Success Reading Initiative to the Governor, the Superintendent of Public Instruction and the appropriate legislative committees.

28 **SECTION 8.** ORS 357.021 is amended to read:

- 29 357.021. (1) The State Library Board is established, consisting of nine voting members.
- 31 (2) The Governor, after consultation with the Oregon Library Association,

- 1 shall appoint seven voting members as follows:
- 2 (a) Two members from two different state agencies;
- 3 (b) One member representing a public library in eastern Oregon;
- 4 (c) One member representing a public library in western Oregon;
- 5 (d) One public member from eastern Oregon;
- 6 (e) One public member from western Oregon; and
- 7 (f) One member representing a community college library or a public 8 university library in this state.
- 9 (3) The [*Deputy*] Superintendent of Public Instruction, or a designee of the 10 [*deputy*] superintendent, shall be a voting member of the board.

9	the effective date of that amendment.
