## SUMMARY

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law. Removes tax year of taxpayer as connection date for certain changes in Internal Revenue Code that are related to definition of “taxable income.”

Expands types of expenses, in conformity with federal law, for which use of withdrawal from higher education savings network account is qualified withdrawal for purpose of tax-advantaged treatment. Conforms age limits, applicable to retirement and to commencing payment of benefits, to federal law, for purposes of Public Employees Retirement System. Applies to transactions or activities occurring on or after January 1, 2021, in tax years beginning on or after January 1, 2021.

Takes effect on 91st day following adjournment sine die.

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1.** ORS 178.300 is amended to read:

10 178.300. As used in ORS 178.300 to 178.360:

11 (1) “Account” means an individual account established in accordance with  
12 ORS 178.300 to 178.360.

13 (2) “Account owner” means the person who has the right to withdraw  
14 funds from the account. The account owner may also be the designated ben-

1 eficiary of the account.

2 (3) “Board” means the Oregon 529 Savings Board established under ORS  
3 178.310.

4 (4) “Designated beneficiary” means, except as provided in ORS 178.350,  
5 the individual designated at the time the account is opened as having the  
6 right to receive a qualified withdrawal for the payment of qualified higher  
7 education expenses, or if the designated beneficiary is replaced in accordance  
8 with ORS 178.350, the replacement.

9 (5) “Financial institution” means a bank, a commercial bank, a national  
10 bank, a savings bank, a savings and loan, a thrift institution, a credit union,  
11 an insurance company, a trust company, a mutual fund, an investment firm  
12 or other similar entity authorized to do business in this state.

13 (6) “Higher education institution” means an eligible education institution  
14 as defined in section 529(e)(5) of the Internal Revenue Code.

15 (7) “Internal Revenue Code” means the federal Internal Revenue Code as  
16 amended and in effect on December 31, [2018] **2020**.

17 (8) “Member of the family” shall have the same meaning as contained in  
18 section 529(e) of the Internal Revenue Code.

19 (9) “Network” means the Oregon 529 Savings Network established under  
20 ORS 178.305.

21 (10) “Nonqualified withdrawal” means a withdrawal from an account that  
22 is not a qualified withdrawal.

23 (11) “Qualified higher education expenses” means tuition and other per-  
24 mitted expenses as set forth in section 529(e) of the Internal Revenue Code  
25 for the enrollment or attendance of a designated beneficiary at a higher ed-  
26 ucation institution, **expenses associated with registered apprenticeship**  
27 **programs described in section 529(c)(8) of the Internal Revenue Code**  
28 **and amounts paid as principal or interest on a qualified education loan**  
29 **to the extent allowed under section 529(c)(9) of the Internal Revenue**  
30 **Code.**

31 (12) “Qualified withdrawal” means a withdrawal made as prescribed under

1 ORS 178.355 and made:

2 (a) From an account to pay the qualified higher education expenses of the  
3 designated beneficiary;

4 (b) As the result of the death or disability of the designated beneficiary;

5 (c) As the result of a scholarship, allowance or payment described in  
6 section 135(d)(1)(A), (B) or (C) of the Internal Revenue Code that is received  
7 by the designated beneficiary, but only to the extent of the amount of the  
8 scholarship, allowance or payment; or

9 (d) As a rollover or change in the designated beneficiary described in ORS  
10 178.350.

11 **SECTION 2.** ORS 238.395 is amended to read:

12 238.395. (1)(a) In addition to any other benefits under this chapter, a death  
13 benefit, provided by contributions of the public employer under ORS 238.225  
14 and, for benefits that accrue on or after July 1, 2020, amounts in the em-  
15 ployee pension stability account established for the member under ORS  
16 238A.353, shall be paid to the beneficiaries designated under ORS 238.390 (1)  
17 of a person who is an active or inactive member of the Public Employees  
18 Retirement System and who dies as a result of injuries received while em-  
19 ployed in the service of the public employer or within 120 days after termi-  
20 nation from service with a participating public employer. A member who is  
21 on a leave of absence without pay from employment with a participating  
22 public employer has not terminated service with that participating public  
23 employer for the purposes of this section.

24 (b) The death benefit under this subsection is an amount equal to the  
25 amount in the member account of the deceased member at the time of death.

26 (c) In the event that a beneficiary has not been named as provided in  
27 paragraph (a) of this subsection and ORS 238.390 (1), the death benefit under  
28 this subsection shall be paid in the manner provided for payment of money  
29 credited to the member account of the member in ORS 238.390 (2).

30 (d) The beneficiary designated under paragraph (a) of this subsection and  
31 ORS 238.390 (1) may elect to receive the amount payable in actuarially de-

1 terminated monthly payments for the life of such beneficiary as long as such  
2 monthly payments, plus the monthly amount if elected under ORS 238.390 (3),  
3 are at least \$200.

4 (e) Interest upon the death benefit provided by this subsection accrues  
5 until the date that the benefit is distributed. The Public Employees Retire-  
6 ment Board shall establish procedures for computing interest to be credited  
7 on the benefit for the period between the date of death and date of distrib-  
8 ution.

9 (2)(a) If a member of the system dies while employed in the service of a  
10 participating public employer or within 120 days after termination from ser-  
11 vice with a participating public employer and the member's spouse is the  
12 member's beneficiary under ORS 238.390, the member's spouse may elect to  
13 receive the benefit provided under this subsection in lieu of the death bene-  
14 fits provided under ORS 238.390 and subsection (1) of this section.

15 (b) The member's spouse must notify the board in writing of an election  
16 under this section no later than 60 days after the date of death of the mem-  
17 ber.

18 (c) The death benefit to be paid under this subsection is for the life of the  
19 member's spouse and is the actuarial equivalent of 50 percent of the service  
20 retirement allowance that would otherwise have been paid to the deceased  
21 member, which shall be calculated:

22 (A) As of the date of death, if the member dies after the earliest retire-  
23 ment date for the member under ORS 238.280; or

24 (B) As if the member became an inactive member on the date of death and  
25 retired at the earliest retirement date for the member under ORS 238.280.

26 (d) The death benefit provided under this subsection is first effective on  
27 the first day of the month following the election of the member's spouse to  
28 receive the death benefit under this subsection. The member's spouse may  
29 elect to delay payment of the death benefit, but payment must commence no  
30 later than December 31 of the calendar year in which the deceased member  
31 would have reached  $[70\frac{1}{2}]$  **72** years of age.

1 (3) Payment by the board of additional death benefits in the manner pro-  
2 vided by this section completely discharges the board and system on account  
3 of the death, and shall hold the board and system harmless from any claim  
4 for wrongful payment.

5 **SECTION 3.** ORS 238A.005 is amended to read:

6 238A.005. For the purposes of this chapter:

7 (1) "Active member" means a member of the pension program or the in-  
8 dividual account program of the Oregon Public Service Retirement Plan who  
9 is actively employed in a qualifying position.

10 (2) "Actuarial equivalent" means a payment or series of payments having  
11 the same value as the payment or series of payments replaced, computed on  
12 the basis of interest rate and mortality assumptions adopted by the board.

13 (3) "Board" means the Public Employees Retirement Board.

14 (4) "Eligible employee" means a person who performs services for a par-  
15 ticipating public employer, including elected officials other than judges.  
16 "Eligible employee" does not include:

17 (a) Persons engaged as independent contractors;

18 (b) Aliens working under a training or educational visa;

19 (c) Persons provided sheltered employment or make-work by a public em-  
20 ployer;

21 (d) Persons categorized by a participating public employer as student  
22 employees;

23 (e) Any person who is in custody in a state institution;

24 (f) Employees of foreign trade offices of the Oregon Business Development  
25 Department who live and perform services in foreign countries under the  
26 provisions of ORS 285A.075 (1)(g);

27 (g) An employee actively participating in an alternative retirement pro-  
28 gram established under ORS 353.250 or an optional retirement plan estab-  
29 lished under ORS 341.551;

30 (h) Employees of a public university listed in ORS 352.002 who are ac-  
31 tively participating in an optional retirement plan offered under ORS 243.815;

1 (i) Persons employed in positions classified as post-doctoral scholar posi-  
2 tions by a public university listed in ORS 352.002, or by the Oregon Health  
3 and Science University, under ORS 350.370;

4 (j) Any employee who belongs to a class of employees that was not eligi-  
5 ble on August 28, 2003, for membership in the system under the provisions  
6 of ORS chapter 238 or other law;

7 (k) Any person who belongs to a class of employees who are not eligible  
8 to become members of the Oregon Public Service Retirement Plan under the  
9 provisions of ORS 238A.070 (2);

10 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS  
11 chapter 238 and who continues to receive retirement benefits while employed;  
12 and

13 (m) Judges.

14 (5) "Firefighter" means:

15 (a) A person employed by a local government, as defined in ORS 174.116,  
16 whose primary job duties include the fighting of fires;

17 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy  
18 state fire marshals;

19 (c) An employee of the State Forestry Department who is certified by the  
20 State Forester as a professional wildland firefighter and whose primary du-  
21 ties include the abatement of uncontrolled fires as described in ORS 477.064;  
22 and

23 (d) An employee of the Oregon Military Department whose primary duties  
24 include fighting structural, aircraft, wildland or other fires.

25 (6) "Fund" means the Public Employees Retirement Fund.

26 (7)(a) "Hour of service" means:

27 (A) An hour for which an eligible employee is directly or indirectly paid  
28 or entitled to payment by a participating public employer for performance  
29 of duties in a qualifying position; and

30 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military  
31 duty or authorized leave during which an employee does not perform duties

1 but for which the employee is directly or indirectly paid or entitled to pay-  
2 ment by a participating public employer for services in a qualifying position,  
3 as long as the hour is within the number of hours regularly scheduled for  
4 the performance of duties during the period of vacation, holiday, illness, in-  
5 capacity, jury duty, military duty or authorized leave.

6 (b) "Hour of service" does not include any hour for which payment is  
7 made or due under a plan maintained solely for the purpose of complying  
8 with applicable unemployment compensation laws.

9 (8) "Inactive member" means a member of the pension program or the  
10 individual account program of the Oregon Public Service Retirement Plan  
11 whose membership has not been terminated, who is not a retired member and  
12 who is not employed in a qualifying position.

13 (9) "Individual account program" means the defined contribution individ-  
14 ual account program of the Oregon Public Service Retirement Plan estab-  
15 lished under ORS 238A.025.

16 (10) "Institution of higher education" means a public university listed in  
17 ORS 352.002, the Oregon Health and Science University or a community  
18 college, as defined in ORS 341.005.

19 (11) "Member" means an eligible employee who has established member-  
20 ship in the pension program or the individual account program of the Oregon  
21 Public Service Retirement Plan and whose membership has not been termi-  
22 nated under ORS 238A.110 or 238A.310.

23 (12) "Participating public employer" means a public employer as defined  
24 in ORS 238.005 that provides retirement benefits for employees of the public  
25 employer under the system.

26 (13) "Pension program" means the defined benefit pension program of the  
27 Oregon Public Service Retirement Plan established under ORS 238A.025.

28 (14) "Police officer" means a police officer as described in ORS 238.005.

29 (15) "Qualifying position" means one or more jobs with one or more par-  
30 ticipating public employers in which an eligible employee performs 600 or  
31 more hours of service in a calendar year, excluding any service in a job for

1 which benefits are not provided under the Oregon Public Service Retirement  
2 Plan pursuant to ORS 238A.070 (2).

3 (16) “Retired member” means a pension program member who is receiving  
4 a pension as provided in ORS 238A.180 to 238A.195.

5 (17)(a) “Salary” means the remuneration paid to an active member in re-  
6 turn for services to the participating public employer, including  
7 remuneration in the form of living quarters, board or other items of value,  
8 to the extent the remuneration is includable in the employee’s taxable in-  
9 come under Oregon law. “Salary” includes the additional amounts specified  
10 in paragraph (b) of this subsection, but does not include the amounts speci-  
11 fied in paragraph (c) of this subsection, regardless of whether those amounts  
12 are includable in taxable income.

13 (b) “Salary” includes the following amounts:

14 (A) Payments of employee and employer money into a deferred compen-  
15 sation plan that are made at the election of the employee.

16 (B) Contributions to a tax-sheltered or deferred annuity that are made at  
17 the election of the employee.

18 (C) Any amount that is contributed to a cafeteria plan or qualified  
19 transportation fringe benefit plan by the employer at the election of the  
20 employee and that is not includable in the taxable income of the employee  
21 by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2018]  
22 **2020**.

23 (D) Any amount that is contributed to a cash or deferred arrangement by  
24 the employer at the election of the employee and that is not included in the  
25 taxable income of the employee by reason of 26 U.S.C. 402(e)(3), as in effect  
26 on December 31, [2018] **2020**.

27 (E) Retroactive payments described in ORS 238.008.

28 (F) The amount of an employee contribution to the individual account  
29 program that is paid by the employer and deducted from the compensation  
30 of the employee, as provided under ORS 238A.335 (1) and (2)(a).

31 (G) The amount of an employee contribution to the individual account



1 program that is not paid by the employer under ORS 238A.335.

2 (H) Wages of a deceased member paid to a surviving spouse or dependent  
3 children under ORS 652.190.

4 (c) "Salary" does not include the following amounts:

5 (A) Travel or any other expenses incidental to employer's business which  
6 is reimbursed by the employer.

7 (B) Payments made on account of an employee's death.

8 (C) Any lump sum payment for accumulated unused sick leave, vacation  
9 leave or other paid leave.

10 (D) Any severance payment, accelerated payment of an employment con-  
11 tract for a future period or advance against future wages.

12 (E) Any retirement incentive, retirement bonus or retirement gratuitous  
13 payment.

14 (F) Payment for a leave of absence after the date the employer and em-  
15 ployee have agreed that no future services in a qualifying position will be  
16 performed.

17 (G) Payments for instructional services rendered to public universities  
18 listed in ORS 352.002 or the Oregon Health and Science University when  
19 those services are in excess of full-time employment subject to this chapter.  
20 A person employed under a contract for less than 12 months is subject to this  
21 subparagraph only for the months covered by the contract.

22 (H) The amount of an employee contribution to the individual account  
23 program that is paid by the employer and is not deducted from the compen-  
24 sation of the employee, as provided under ORS 238A.335 (1) and (2)(b).

25 (I) Compensation described and authorized under ORS 341.556 that is not  
26 paid by the community college employing the faculty member.

27 (J) Compensation described and authorized under ORS 352.232 that is not  
28 paid by the public university employing the officer or employee.

29 (K) Compensation described and authorized under ORS 353.270 that is not  
30 paid by Oregon Health and Science University.

31 (L) For years before 2020, any amount in excess of \$200,000 for a calendar

1 year. If any period over which salary is determined is less than 12 months,  
2 the \$200,000 limitation for that period shall be multiplied by a fraction, the  
3 numerator of which is the number of months in the determination period and  
4 the denominator of which is 12. The board shall adopt rules adjusting this  
5 dollar limit to incorporate cost-of-living adjustments authorized by the  
6 Internal Revenue Service.

7 (M) For years beginning on or after January 1, 2020, any amount in excess  
8 of \$195,000 for a calendar year. If any period over which salary is determined  
9 is less than 12 months, the \$195,000 limitation for that period shall be  
10 multiplied by a fraction, the numerator of which is the number of months in  
11 the determination period and the denominator of which is 12. On January 1  
12 of each year, the board shall adjust the dollar limit provided by this sub-  
13 paragraph to reflect any percentage changes in the Consumer Price Index for  
14 All Urban Consumers, West Region (All Items), as published by the Bureau  
15 of Labor Statistics of the United States Department of Labor.

16 (18) "System" means the Public Employees Retirement System.

17 (19) "Workers' compensation benefits" means:

18 (a) Payments made under ORS chapter 656; or

19 (b) Payments provided in lieu of workers' compensation benefits under  
20 ORS 656.027 (6).

21 **SECTION 4.** ORS 238A.125 is amended to read:

22 238A.125. (1) Upon retiring at normal retirement age, a vested pension  
23 program member shall be paid an annual pension for the life of the member  
24 as follows:

25 (a) For service as a police officer or firefighter, 1.8 percent of final aver-  
26 age salary multiplied by the number of years of retirement credit attributable  
27 to service as a police officer or firefighter.

28 (b) For service as other than a police officer or firefighter, 1.5 percent  
29 of final average salary multiplied by the number of years of retirement credit  
30 attributable to service as other than a police officer or firefighter.

31 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the an-

1 nual benefit payable to a member under the pension program and under any  
2 other tax-qualified defined benefit plan maintained by the participating pub-  
3 lic employer may not exceed the applicable limitations set forth in 26 U.S.C.  
4 415(b), as in effect on December 31, [2018] **2020**. The Public Employees Re-  
5 tirement Board shall adopt rules for the administration of this limitation,  
6 including adjustments in the annual dollar limitation to reflect cost-of-living  
7 adjustments authorized by the Internal Revenue Service.

8 (3) The board shall make no actuarial adjustment in a member's pension  
9 calculated under this section by reason of the member's retirement after  
10 normal retirement age.

11 **SECTION 5.** ORS 238A.150 is amended to read:

12 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to  
13 238A.250, an eligible employee who leaves a qualifying position for the pur-  
14 pose of performing service in the uniformed services, and who subsequently  
15 returns to employment with a participating public employer with reemploy-  
16 ment rights under federal law, is entitled to accrue retirement credit, credit  
17 toward the probationary period required by ORS 238A.100 and credit toward  
18 the vesting requirements of ORS 238A.115 under rules adopted by the Public  
19 Employees Retirement Board pursuant to subsection (2) of this section.

20 (2) The board shall adopt rules establishing benefits and service credit for  
21 any period of service in the uniformed services by an employee described in  
22 subsection (1) of this section. For the purpose of adopting rules under this  
23 subsection, the board shall consider and take into account all federal law  
24 relating to benefits and service credit for any period of service in the uni-  
25 formed services, including 26 U.S.C. 414(u), as in effect on December 31,  
26 [2018] **2020**. Benefits and service credit under rules adopted by the board  
27 pursuant to this subsection may not exceed benefits and service credit re-  
28 quired under federal law for periods of service in the uniformed services.

29 **SECTION 6.** ORS 238A.170 is amended to read:

30 238A.170. (1) An active member of the pension program who is [70-1/2] **72**  
31 years of age or older must retire not later than April 1 of the calendar year

1 following the calendar year in which the member terminates employment  
2 with all participating public employers. An inactive member of the pension  
3 program must retire not later than April 1 of the calendar year following the  
4 calendar year in which the member attains [70-1/2] **72** years of age.

5 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the  
6 entire interest of a member of the pension program must be distributed over  
7 a time period commencing no later than the required beginning date set forth  
8 in subsection (1) of this section, and must be distributed in a manner that  
9 satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9)  
10 and regulations implementing that section, as in effect on [December 31,  
11 2018] **January 1, 2020**. The Public Employees Retirement Board shall adopt  
12 rules implementing those minimum distribution requirements.

13 **SECTION 7.** ORS 238A.230 is amended to read:

14 238A.230. (1) If a member of the pension program who is vested dies before  
15 the member's effective date of retirement, the Public Employees Retirement  
16 Board shall pay the death benefit provided for in this section to:

17 (a) The spouse of the member to the extent not provided to a former  
18 spouse in accordance with a judgment or order under ORS 238.465;

19 (b) The former spouse of the member as provided in a judgment or order  
20 under ORS 238.465; or

21 (c) Any other person who is constitutionally required to be treated in the  
22 same manner as a spouse for the purpose of retirement benefits.

23 (2)(a) The death benefit to be paid under this section shall be for the life  
24 of the spouse, former spouse or other person who is constitutionally required  
25 to be treated in the same manner as a spouse, and shall be the actuarial  
26 equivalent of 50 percent of the pension that would otherwise have been paid  
27 to the deceased member.

28 (b) For the purpose of paragraph (a) of this subsection, the amount of the  
29 pension that would otherwise have been paid to the deceased member shall  
30 be calculated:

31 (A) As of the date of death if the member dies after the earliest retirement

1 date for the member under ORS 238A.165; or

2 (B) As if the member became an inactive member on the date of death and  
3 thereafter retired at the earliest retirement date if the member dies before  
4 the earliest retirement date for the member under ORS 238A.165.

5 (3) The death benefit provided under this section is first effective on the  
6 first day of the month following the date of death of the member. The sur-  
7 viving spouse, former spouse or other person entitled to the death benefit  
8 may elect to delay payment of the death benefit, but payment must commence  
9 no later than December 31 of the calendar year in which the member would  
10 have reached [70-1/2] **72** years of age.

11 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250,  
12 distributions of death benefits under the pension program must comply with  
13 the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regu-  
14 lations implementing that section, as in effect on [December 31, 2018] **Janu-**  
15 **ary 1, 2020**. The board shall adopt rules implementing those minimum  
16 distribution requirements.

17 **SECTION 8.** ORS 238A.370 is amended to read:

18 238A.370. Notwithstanding any other provision of ORS 238A.300 to  
19 238A.415, the annual addition to the employee and employer accounts of a  
20 member of the individual account program for a calendar year, together with  
21 the annual additions to the accounts of the member under any other defined  
22 contribution plan maintained by the participating public employer for a cal-  
23 endar year, may not exceed the lesser of \$40,000, or 100 percent of the  
24 member's compensation for that calendar year. For purposes of this section,  
25 "annual addition" has the meaning given that term in 26 U.S.C. 415(c)(2),  
26 as in effect on December 31, [2018] **2020**, and "compensation" has the meaning  
27 given the term "participant's compensation" in 26 U.S.C. 415(c)(3), as in ef-  
28 fect on December 31, [2018] **2020**. The Public Employees Retirement Board  
29 shall adopt rules for the administration of this limitation, including adjust-  
30 ments in the annual dollar limitation to reflect cost-of-living adjustments  
31 authorized by the Internal Revenue Service.

1       **SECTION 9.** ORS 238A.400 is amended to read:

2       238A.400. (1) Upon retirement on or after the earliest retirement date, as  
3 described in ORS 238A.165, a member of the individual account program shall  
4 receive in a lump sum the amounts in the member's employee account,  
5 rollover account and employer account to the extent the member is vested  
6 in those accounts under ORS 238A.320.

7       (2) In lieu of a lump sum payment under subsection (1) of this section, a  
8 member of the individual account program may elect to receive the amounts  
9 in the member's employee account and employer account, to the extent the  
10 member is vested in those accounts under ORS 238A.320, in substantially  
11 equal installments paid over a period of 5, 10, 15 or 20 years, or over a period  
12 that is equal to the anticipated life span of the member as actuarially de-  
13 termined by the Public Employees Retirement Board. Installments may be  
14 made on a monthly, quarterly or annual basis. In no event may the period  
15 selected by the member exceed the time allowed by the minimum distribution  
16 requirements described in subsection (5) of this section. The board shall by  
17 rule establish the manner in which installments will be adjusted to reflect  
18 investment gains and losses on the unpaid balance during the payout period  
19 elected by the member under this subsection. The board by rule may estab-  
20 lish minimum monthly amounts payable under this subsection. The board  
21 may require that a lump sum payment, or an installment schedule different  
22 than the schedules provided for in this subsection, be used to pay the vested  
23 amounts in the member's accounts if those amounts are not adequate to  
24 generate the minimum monthly amounts specified by the rule.

25       (3) A member of the individual account program electing to receive in-  
26 stallments under subsection (2) of this section must designate a beneficiary  
27 or beneficiaries. In the event the member dies before all amounts in the

4 making loan certifications under subsection (7) of this section, the Housing  
5 and Community Services Department shall attempt to distribute the tax  
6 credits statewide, but shall concentrate the tax credits in those areas of the  
7 state that are determined by the Oregon Housing Stability Council to have  
8 the greatest need for affordable housing.

9 (9) The tax credit provided for in this section may be taken whether or  
10 not:

11 (a) The financial institution is eligible to take a federal income tax credit  
12 under section 42 of the Internal Revenue Code with respect to the project  
13 financed by the qualified loan; or

14 (b) The project receives financing from bonds, the interest on which is  
15 exempt from federal taxation under section 103 of the Internal Revenue Code.

16 (10) For a qualified loan defined in subsection (1)(i)(B) of this section fi-  
17 nanced through the purchase of bonds, the interest of which is exempt from  
18 federal taxation under section 103 of the Internal Revenue Code, the amount  
19 of finance charge that would have been charged under subsection (2)(b) of  
20 this section is determined by reference to the finance charge that would have

1 transactions between a reciprocal insurer and its attorney in fact operating  
2 under ORS 731.142;

3 (D) Receipts from hedging transactions, to the extent that the trans-

5 chapter, or voluntary payments permitted, to be made to the Unemployment  
6 Compensation Trust Fund.

7 (6) "Educational institution," including an institution of higher education  
8 as defined in subsection (9) of this section, means an institution:

9 (a) In which participants, trainees or students are offered an organized  
10 course of study or training designed to transfer to them knowledge, skills,  
11 information, doctrines, attitudes or abilities from, by or under the guidance  
12 of an instructor or teacher;

13 (b) That is accredited, registered, approved, licensed or issued a permit  
14 to operate as a school by the Department of Education or other government  
15 agency, or that offers courses for credit that are transferable to an approved,  
16 registered or accredited school;

17 (c) In which the course or courses of study or training that it offers may  
18 be academic, technical, trade or preparation for gainful employment in a re-  
19 cognized occupation; and

20 (d) In which the course or courses of study or training are offered on a  
21 regular and continuing basis.

22 (7) "Employment office" means a free public employment office or branch  
23 thereof, operated by this state or maintained as a part of a state-controlled  
24 system of public employment offices.

25 (8) "Hospital" means an organization that has been licensed, certified or  
26 approved by the Oregon Health Authority as a hospital.

27 (9) "Institution of higher education" means an educational institution  
28 that:

29 (a) Admits as regular students only individuals having a certificate of  
30 graduation from a high school, or the recognized equivalent of such a cer-  
31 tificate;



1 (b) Is legally authorized in this state to provide a program of education  
2 beyond high school;

3 (c) Provides an educational program for which it awards a bachelor's or  
4 higher degree, or provides a program that is acceptable for full credit toward  
5 such a degree, a program of post-graduate or post-doctoral studies, or a pro-  
6 gram of training to prepare students for gainful employment in a recognized  
7 occupation; and

8 (d) Is a public or other nonprofit institution.

9 (10) "Internal Revenue Code" means the federal Internal Revenue Code,  
10 as amended and in effect on December 31, [2018] **2020**.

11 (11) "Nonprofit employing unit" means an organization, or group of or-  
12 ganizations, described in section 501(c)(3) of the Internal Revenue Code that  
13 is exempt from income tax under section 501(a) of the Internal Revenue Code.

14 (12) "State" includes, in addition to the states of the United States of  
15 America, the District of Columbia and Puerto Rico. However, for all pur-  
16 poses of this chapter the Virgin Islands shall be considered a state on and  
17 after the day on which the United States Secretary of Labor first approves  
18 the Virgin Islands' law under section 3304(a) of the Federal Unemployment  
19 Tax Act as amended by Public Law 94-566.

20 (13) "Taxes" means the money payments to the Unemployment Compen-  
21 sation Trust Fund required, or voluntary payments permitted, by this chap-  
22 ter.

23 (14) "Valid claim" means any claim for benefits made in accordance with  
24 ORS 657.260 if the individual meets the wages-paid-for-employment require-  
25 ments of ORS 657.150.

26 (15) "Week" means any period of seven consecutive calendar days ending  
27 at midnight, as the director may, by regulation, prescribe. The director may  
28 by regulation prescribe that a "week" shall be "in," "within," or "during" the  
29 calendar quarter that includes the greater part of such week.

30 **SECTION 31.** ORS 657B.010 is amended to read:

31 657B.010. As used in this chapter:

1 (1) "Alternate base year" means the last four completed calendar quarters  
2 preceding the benefit year.

3 (2) "Average weekly wage" means the amount calculated by the Employ-  
4 ment Department as the state average weekly covered wage under ORS  
5 657.150 (4)(d) as determined not more than once per year.

6 (3) "Base year" means the first four of the last five completed calendar  
7 quarters preceding the benefit year.

8 (4) "Benefits" means family and medical leave insurance benefits.

9 (5) "Benefit year" means the 12-month period as determined by the Di-  
10 rector of the Employment Department by rule under ORS 657B.340.

11 (6) "Child" means:

12 (a) A biological child, adopted child, stepchild or foster child of a covered  
13 individual or of the covered individual's spouse or domestic partner;

14 (b) A person who is or was a legal ward of a covered individual or of the  
15 covered individual's spouse or domestic partner; or

16 (c) A person who is or was in a relationship of in loco parentis with a  
17 covered individual or with the covered individual's spouse or domestic part-  
18 ner.

19 (7) "Contribution" or "contributions" means the money payments made  
20 by any of the following under ORS 657B.150:

21 (a) An employer;

22 (b) An eligible employee;

23 (c) A self-employed individual;

24 (d) A tribal government; or

25 (e) An employee of a tribal government.

26 (8) "Covered individual" means any one of the following who qualifies to  
27 receive family and medical leave insurance benefits:

28 (a) An eligible employee;

29 (b) A self-employed individual; or

30 (c) An employee of a tribal government.

31 (9) "Domestic partner" means an individual joined in a domestic partner-

1 ship.

2 (10) “Domestic partnership” has the meaning given that term in ORS  
3 106.310.

4 (11) “Eligible employee” means:

5 (a)(A) An employee who has earned at least \$1,000 in wages during the  
6 base year; or

7 (B) If an employee has not earned at least \$1,000 in wages during the base  
8 year, an employee who has earned at least \$1,000 in wages during the alter-  
9 nate base year; and

10 (b) Who may apply for paid family and medical leave insurance benefits  
11 under ORS 657B.015.

12 (12) “Eligible employee’s average weekly wage” means an amount calcu-  
13 lated by the Director of the Employment Department by dividing the total  
14 wages earned by an eligible employee during the base year by the number  
15 of weeks in the base year.

16 (13)(a) “Employee” means:

17 (A) An individual performing services for an employer for remuneration  
18 or under any contract of hire, written or oral, express or implied.

19 (B) A home care worker as defined in ORS 410.600.

20 (b) “Employee” does not include:

21 (A) An independent contractor as defined in ORS 670.600.

22 (B) A participant in a work training program administered under a state  
23 or federal assistance program.

24 (C) A participant in a work-study program that provides students in sec-  
25 ondary or postsecondary educational institutions with employment opportu-  
26 nities for financial assistance or vocational training.

27 (D) A railroad worker exempted under the federal Railroad Unemployment  
28 Insurance Act.

29 (E) A volunteer.

30 (14)(a) “Employer” means any person that employs one or more employees  
31 working anywhere in this state or any agent or employee of such person to

1 whom the duties of the person under this chapter have been delegated.

2 (b) "Employer" includes:

3 (A) A political subdivision of this state or any county, city, district, au-  
4 thority or public corporation, or any instrumentality of a county, city, dis-  
5 trict, authority or public corporation, organized and existing under law or  
6 charter;

7 (B) An individual;

8 (C) Any type of organization, corporation, partnership, limited liability  
9 company, association, trust, estate, joint stock company or insurance com-  
10 pany;

11 (D) Any successor in interest to an entity described in subparagraph (C)  
12 of this paragraph;

13 (E) A trustee, trustee in bankruptcy or receiver; or

14 (F) A trustee or legal representative of a deceased person.

15 (c) "Employer" does not include the federal government or a tribal gov-  
16 ernment.

17 (15) "Employment agency" has the meaning given that term in ORS  
18 658.005.

19 (16) "Family and medical leave insurance benefits" means the wage re-  
20 placement benefits that are available to a covered individual under ORS  
21 657B.050 or under the terms of an employer plan approved under ORS  
22 657B.210, for family leave, medical leave or safe leave.

23 (17)(a) "Family leave" means leave from work taken by a covered indi-  
24 vidual:

25 (A) To care for and bond with a child during the first year after the  
26 child's birth or during the first year after the placement of the child through  
27 foster care or adoption; or

28 (B) To care for a family member with a serious health condition.

29 (b) "Family leave" does not mean:

30 (A) Leave described in ORS 659A.159 (1)(d);

31 (B) Leave described in ORS 659A.159 (1)(e); or

1 (C) Leave authorized under ORS 659A.093.

2 (18) "Family member" means:

3 (a) The spouse of a covered individual;

4 (b) A child of a covered individual or the child's spouse or domestic  
5 partner;

6 (c) A parent of a covered individual or the parent's spouse or domestic  
7 partner;

8 (d) A sibling or stepsibling of a covered individual or the sibling's or  
9 stepsibling's spouse or domestic partner;

10 (e) A grandparent of a covered individual or the grandparent's spouse or  
11 domestic partner;

12 (f) A grandchild of a covered individual or the grandchild's spouse or  
13 domestic partner;

14 (g) The domestic partner of a covered individual; or

15 (h) Any individual related by blood or affinity whose close association  
16 with a covered individual is the equivalent of a family relationship.

17 (19) "Medical leave" means leave from work taken by a covered individual  
18 that is made necessary by the individual's own serious health condition.

19 (20) "Parent" means:

20 (a) A biological parent, adoptive parent, stepparent or foster parent of a  
21 covered individual;

22 (b) A person who was a foster parent of a covered individual when the  
23 covered individual was a minor;

24 (c) A person designated as the legal guardian of a covered individual at  
25 the time the covered individual was a minor or required a legal guardian;

26 (d) A person with whom a covered individual was or is in a relationship  
27 of in loco parentis; or

28 (e) A parent of a covered individual's spouse or domestic partner who  
29 meets a description under paragraphs (a) to (d) of this subsection.

30 (21) "Safe leave" means leave taken for any purpose described in 659A.272.

31 (22) "Self-employed individual" means:

1 (a) An individual who has self-employment income as defined in section  
2 1402(b) of the Internal Revenue Code as amended and in effect on December  
3 31, [2018] **2020**; or

4 (b) An independent contractor as defined in ORS 670.600.

5 (23) “Serious health condition” has the meaning given that term in ORS  
6 659A.150.

7 (24) “Third party administrator” means a third party that enters into an  
8 agreement with the Director of the Employment Department to implement  
9 and administer the paid family and medical leave program established under  
10 this chapter.

11 (25) “Tribal government” has the meaning given that term in ORS  
12 181A.680.

13 (26) “Wages” has the meaning given that term in ORS 657.105.

14 **SECTION 32. (1) Except as provided in subsections (2) and (3) of this**  
15 **section, the amendments to statutes by sections 1 to 31 of this 2021**  
16 **Act apply to transactions or activities occurring on or after January**  
17 **1, 2021, in tax years beginning on or after January 1, 2021.**

18 **(2) The effective and applicable dates, and the exceptions, special**  
19 **rules and coordination with the Internal Revenue Code, as amended,**  
20 **relative to those dates, contained in federal law amending the Internal**  
21 **Revenue Code and enacted before January 1, 2021, apply for Oregon**  
22 **personal income and corporate excise and income tax purposes, to the**  
23 **extent they can be made applicable, in the same manner as they are**  
24 **applied under the Internal Revenue Code and related federal law.**

25 **(3)(a) If a deficiency is assessed against any taxpayer for a tax year**  
26 **beginning before January 1, 2021, and the deficiency or any portion**  
27 **thereof is attributable to any retroactive treatment under the amend-**  
28 **ments to ORS 178.300, 305.230, 305.494, 305.690, 305.842, 314.011, 314.306,**  
29 **315.004, 316.012, 316.013, 316.147, 316.157, 317.010, 317.018, 317.097 and**  
30 **317A.100 by sections 1 and 14 to 28 of this 2021 Act, then any interest**  
31 **or penalty assessed under ORS chapter 305, 314, 315, 316, 317, 317A or**

1 **318 with respect to the deficiency or portion thereof shall be canceled.**

2 **(b) If a refund is due any taxpayer for a tax year beginning before**  
3 **January 1, 2021, and the refund or any portion thereof is due the tax-**  
4 **payer on account of any retroactive treatment under the amendments**  
5 **to ORS 178.300, 305.230, 305.494, 305.690, 305.842, 314.011, 314.306, 315.004,**  
6 **316.012, 316.013, 316.147, 316.157, 317.010, 317.018, 317.097 and 317A.100 by**  
7 **sections 1 and 14 to 28 of this 2021 Act, for a tax year beginning before**  
8 **January 1, 2021, then notwithstanding ORS 305.270 or 314.415 or any**  
9 **other law, the refund or portion thereof shall be paid without interest.**

10 **(c) Any changes required because of the amendments to ORS**  
11 **178.300, 305.230, 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012,**  
12 **316.013, 316.147, 316.157, 317.010, 317.018, 317.097 and 317A.100 by sections**  
13 **1 and 14 to 28 of this 2021 Act, for a tax year beginning before January**  
14 **1, 2021, shall be made by filing an amended return within the time**  
15 **prescribed by law.**

16 **(d) If a taxpayer fails to file an amended return under paragraph**  
17 **(c) of this subsection, the Department of Revenue shall make any**  
18 **changes under paragraph (c) of this subsection on the return to which**  
19 **the changes relate within the period specified for issuing a notice of**  
20 **deficiency or claiming a refund as otherwise provided by law with re-**  
21 **spect to that return, or within one year after a return for a tax year**  
22 **beginning on or after January 1, 2021, and before January 1, 2022, is**  
23 **filed, whichever period expires later.**

24 **SECTION 33. This 2021 Act takes effect on the 91st day after the**  
25 **date on which the 2021 regular session of the Eighty-first Legislative**  
26 **Assembly adjourns sine die.**
