## **SUMMARY**

Directs court to consider, in determining amount of award of attorney fees, whether attorney performed services on pro bono basis or award of attorney fees otherwise promotes access to justice.

## 1 A BILL FOR AN ACT

- 2 Relating to attorney fees; creating new provisions; and amending ORS 20.075.
- 3 Be It Enacted by the People of the State of Oregon:
- 4 **SECTION 1.** ORS 20.075 is amended to read:
- 5 20.075. (1) A court shall consider the following factors in determining
- 6 whether to award attorney fees in any case in which an award of attorney
- 7 fees is authorized by statute and in which the court has discretion to decide
- 8 whether to award attorney fees:

- 9 (a) The conduct of the parties in the transactions or occurrences that
- 10 gave rise to the litigation, including any conduct of a party that was reck-
- 11 less, willful, malicious, in bad faith or illegal.
- 12 (b) The objective reasonableness of the claims and defenses asserted by 13 the parties.
- 14 (c) The extent to which an award of an attorney fee in the case would 15 deter others from asserting good faith claims or defenses in similar cases.
- 16 (d) The extent to which an award of an attorney fee in the case would 17 deter others from asserting meritless claims and defenses.
- 18 (e) The objective reasonableness of the parties and the diligence of the 19 parties and their attorneys during the proceedings.
  - (f) The objective reasonableness of the parties and the diligence of the

- 1 parties in pursuing settlement of the dispute.
- 2 (g) The amount that the court has awarded as a prevailing party fee under 3 ORS 20.190.
- 4 (h) Such other factors as the court may consider appropriate under the 5 circumstances of the case.
- 6 (2) A court shall consider the factors specified in subsection (1) of this
  7 section in determining the amount of an award of attorney fees in any case
  8 in which an award of attorney fees is authorized or required by statute. In
  9 addition, the court shall consider the following factors in determining the
  10 amount of an award of attorney fees in those cases:
- 11 (a) The time and labor required in the proceeding, the novelty and diffi-12 culty of the questions involved in the proceeding and the skill needed to 13 properly perform the legal services.
- (b) The likelihood, if apparent to the client, that the acceptance of the particular employment by the attorney would preclude the attorney from taking other cases.
- 17 (c) The fee customarily charged in the locality for similar legal services.
- 18 (d) The amount involved in the controversy and the results obtained.
- 19 (e) The time limitations imposed by the client or the circumstances of the 20 case.
- 21 (f) The nature and length of the attorney's professional relationship with 22 the client.
- 23 (g) The experience, reputation and ability of the attorney performing the services.
- 25 (h) Whether the fee of the attorney is fixed or contingent.
- 26 (i) Whether the attorney performed the services on a pro bono basis 27 or the award of attorney fees otherwise promotes access to justice.
- 28 (3) In any appeal from the award or denial of an attorney fee subject to 29 this section, the court reviewing the award may not modify the decision of 30 the court in making or denying an award, or the decision of the court as to 31 the amount of the award, except upon a finding of an abuse of discretion.
