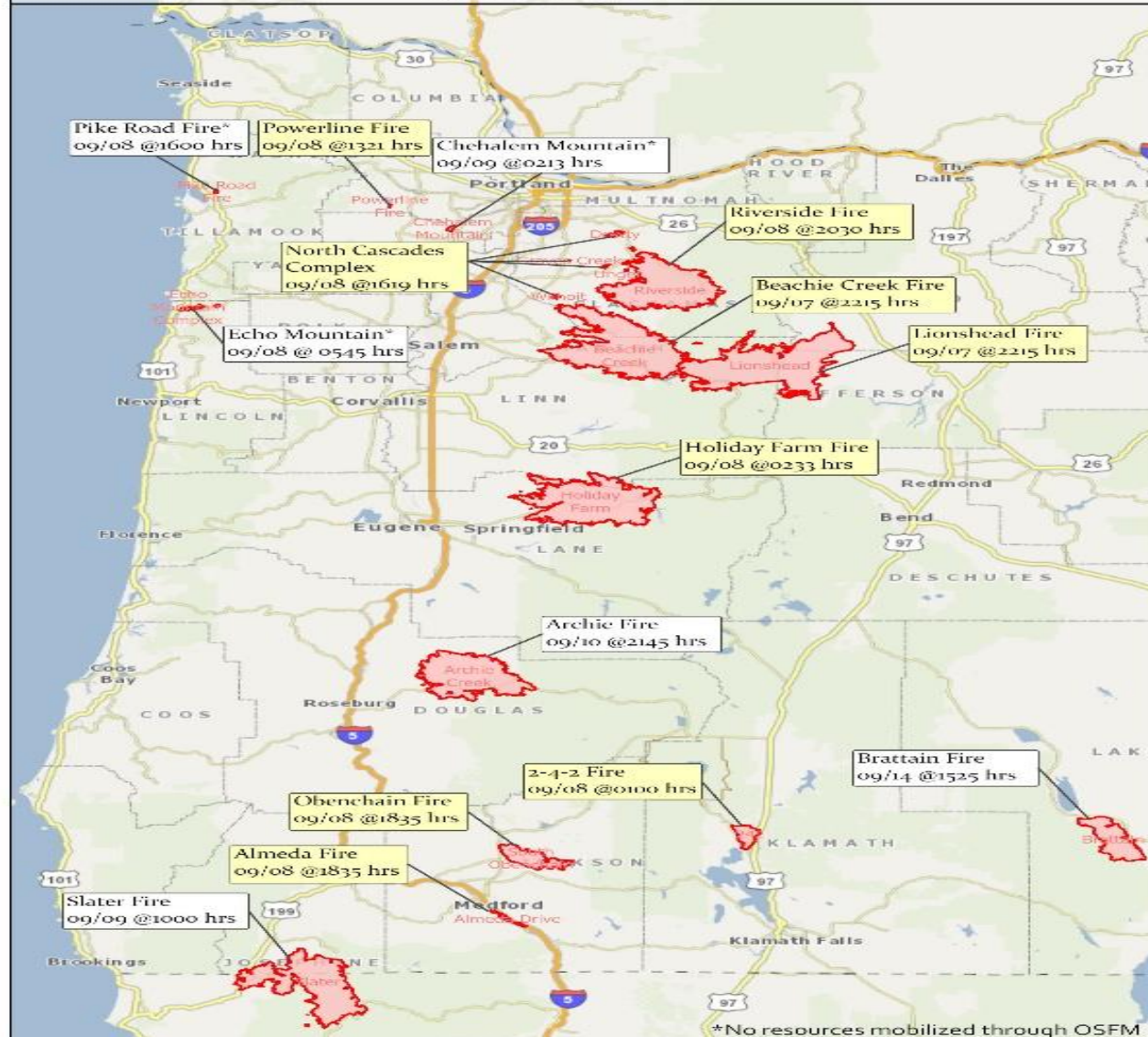

# OSFM-2020 Fire Season – By the Numbers

## Response:

- Record number of Conflagrations
  - 18 Mobilizations,
  - 14 Conflagrations
  - 1 Statewide Declaration
- 180 Fire Agencies Responding
  - Over 60% of Fire Agencies
  - Over 40% of responders were volunteer firefighters
- 12 Counties Impacted



## Impacts:

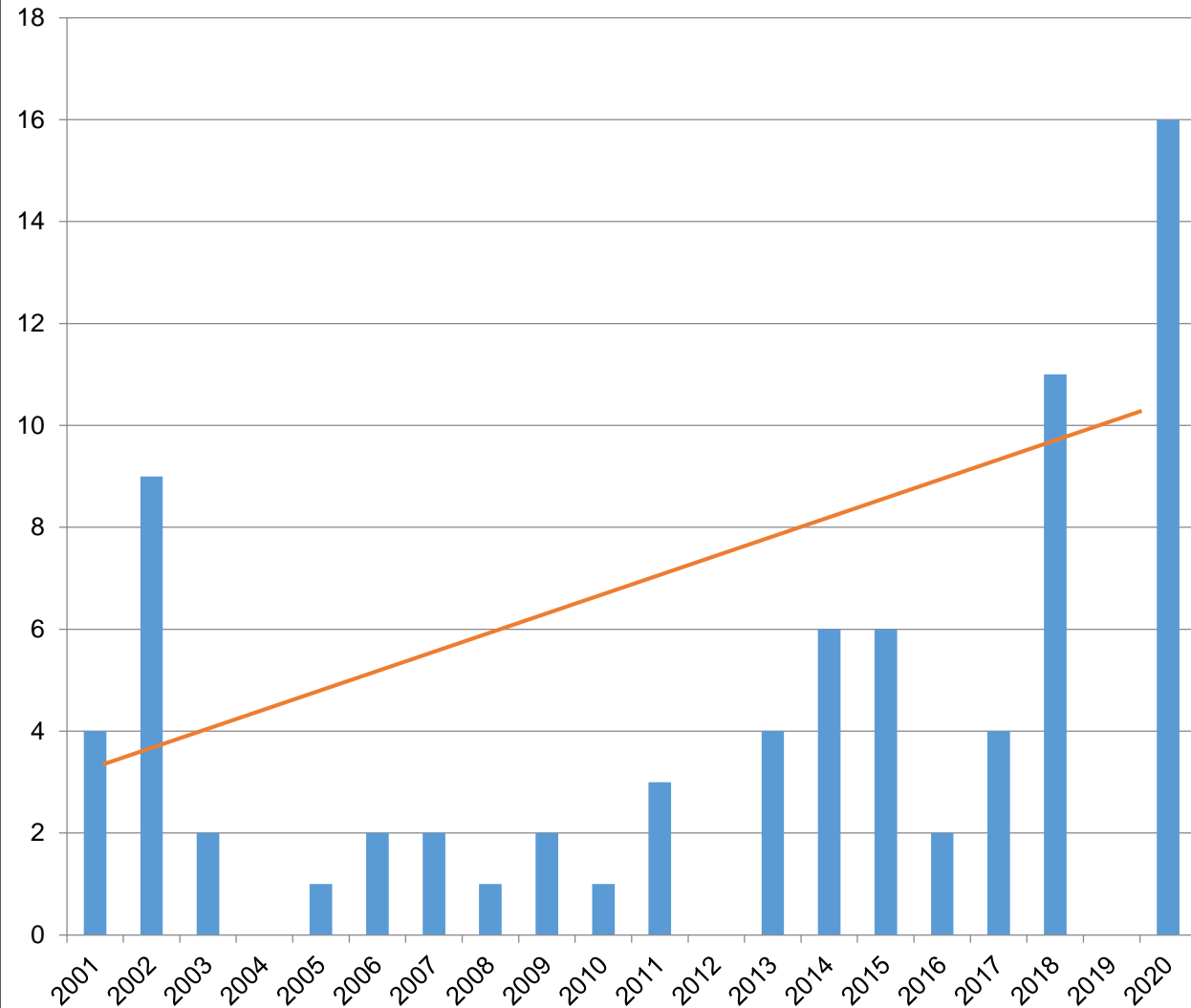
- 172,427 threatened structures
  - \$43,463,314,807 estimated value of saved residences
- 4,026 residences destroyed
- 9 confirmed fatalities

## OSFM costs to date:

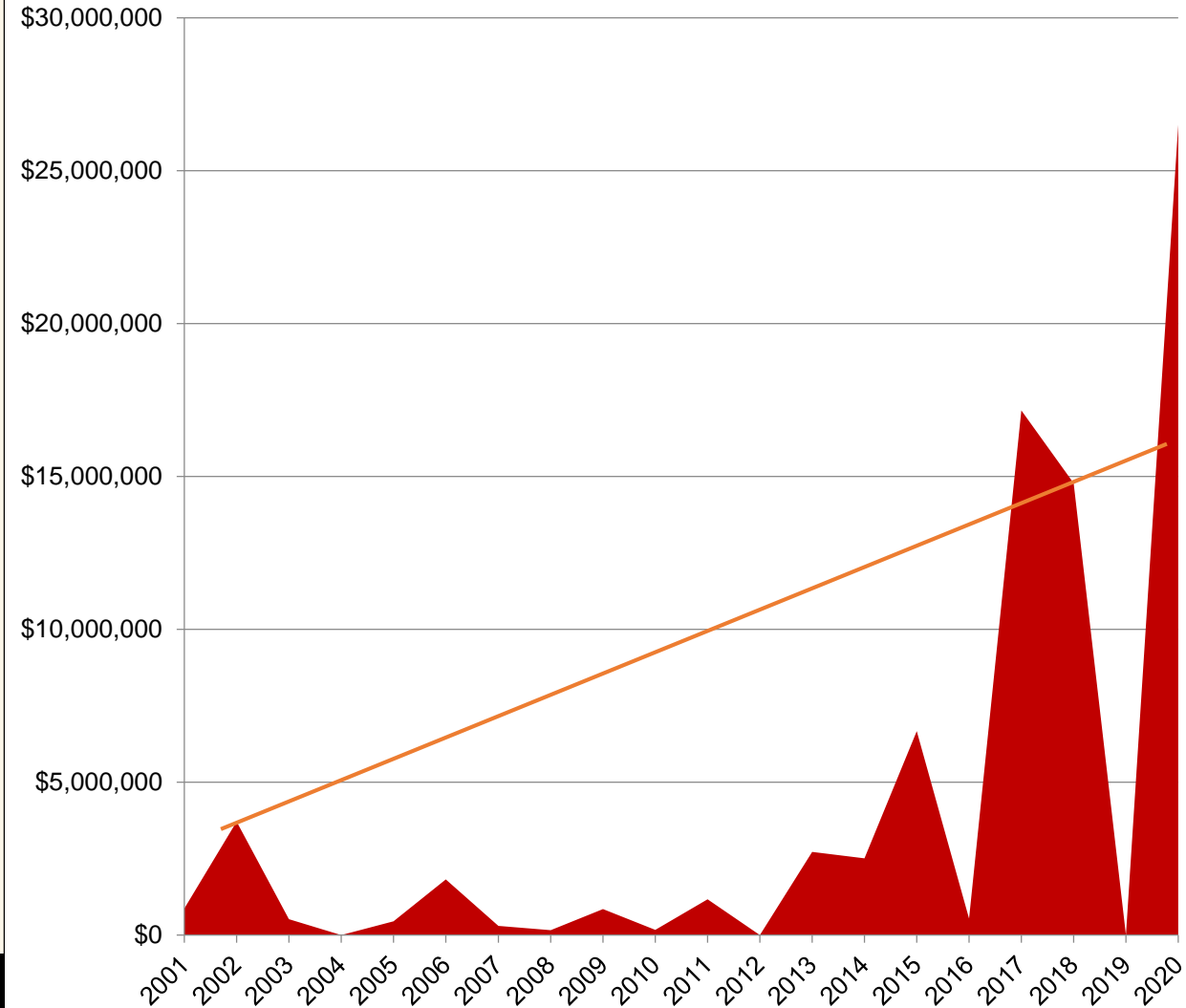
- \$ 26.5 Million
  - \$6,625,000 State Share

## OREGON FIRE MUTUAL AID SYSTEM



### 1. Local Response

Initial attack by AHJ or nearby agencies



### 2. Local Mutual Aid

Local agency agreements used to bring in partners from neighboring jurisdictions



### 3. Expanded Mutual Aid

Local agency agreements which may be county-wide or inter-county used to bolster capability



### 4. Statewide Mutual Aid

Conflagration or other state-level response by resources mobilized by State Fire Marshal



### 5. Interstate Mutual Aid

State-level agreements allowing resources from other states to respond

  - ✓ Prepare Responders and Oregonians



# COVID 19 and Fire Camps - 2020 & 2021

- **Best Management Practices**

- Elimination of congregant settings; regular screening; module as one concept

- **COVID-19 Modules**

- Fire personnel assigned to implement Covid-19 mitigation measures

- **No Fire Camp Outbreaks**

- 9,250 individuals assigned to fire camps at peak of activity on Sept 9

- **2021 & moving forward:**

- Covid-19 needs to be planned for to ensure protection of our communities and firefighters

  - Conflagration Large Fire Funding
