

Research & Data Indicate

There are two keys to returning to in-person:

- One is following public safety protocols in the school with fidelity. This
 includes entry screening, face coverings, physical distancing, cohorting,
 and frequent handwashing. While we see cases introduced to schools,
 we are not seeing much transmission at school.
- The other is to get the community case counts to a low enough number that we are not regularly introducing COVID-19 into the school - which destabilizes the learning environment as contact tracing leads to quarantining. This is where Oregon is struggling.



Managing Loss of Learning

We can't wait!

- ✓ Limited in-person instruction is our equity strategy
- ✓ Small groups, even virtually
- School-by-school plan that monitors engagement and student progress using our multi-tiered systems of support.
- ✓ Mentors and tutors, especially for seniors and 9th grade students not on track
- ✓ Partnership with Chemeketa for seniors as they transition to college

✓ Robust summer school

School Year 2021-22

✓ Planning *now* for how we will look different in the fall of 2021



What can the state do to help?

- > Maximum flexibility to support operations, teaching and learning.
- ➤ Clear path for getting our students back to schools, even if through limited in-person instruction. A clear demand for this from the state level helps us.
- ➤ COVID relief package for students clear budget item to provide academic support for students due to loss of academic learning.
- ➤ Waivers anywhere possible across multiple agencies, not just for schools. How can any agency that serves children and their families right now do things that support the education of our students?
- > Support for **full summer-school program**.
- ➤ Adequate funding for the State School Fund in the next biennium. Our students will need more, not less.
