SUMMARY

Establishes Task Force on Disaster Response and Recovery. Directs task force, inter alia, to identify locations suitable for emergency preparedness, response and recovery needs, identify projects to prepare Redmond Municipal Airport and Oregon International Port of Coos Bay for use in emergency, and identify other projects to increase emergency resilience of this state. Requires report to Legislative Assembly by September 15, 2022.

Sunsets on December 31, 2022.

A BILL FOR AN ACT

- 2 Relating to emergency resilience; and prescribing an effective date.
- 3 Be It Enacted by the People of the State of Oregon:
- 4 <u>SECTION 1.</u> (1) The Task Force on Disaster Response and Recovery 5 is established.
 - (2) The task force consists of 35 members appointed as follows:
 - (a) The President of the Senate shall appoint two members from among members of the Senate, one of whom must be the chair of the Senate Committee on Veterans and Emergency Preparedness.
- 10 (b) The Speaker of the House of Representatives shall appoint two 11 members from among members of the House of Representatives, one 12 of whom must be the chair of the House Committee on Veterans and 13 Emergency Preparedness.
- 14 (c) The Governor shall appoint as members one representative from 15 each of:
 - (A) The Oregon Military Department;
 - (B) The Office of Emergency Management;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

- 23 (Y) The Water Resources Department.
- 24 (d) The Governor shall appoint five members as follows:
- 25 (A) One member representing counties in this state;
- 26 (B) One member representing cities in this state;
- 27 (C) One member representing special districts in this state;
- 28 (D) One member representing the American Red Cross or a similar
- 29 organization; and
- 30 (E) One member of the public who has experience or interest in
- 31 disaster response and recovery.

- 1 (e) The Chief Justice of the Supreme Court shall appoint one 2 member representing the Judicial Department.
- 3 (3) The task force shall:
- 4 (a) Identify locations that are suitable or may be made suitable for 5 emergency preparedness, response and recovery needs, including:
- 6 (A) Rally points or gathering points for individuals displaced in an emergency;
- 8 (B) Spaces for staging emergency response equipment or personnel; 9 and
- 10 (C) Recovery spaces for medium-term care, housing and support for 11 individuals during an emergency;
- 12 **(b)** Identify projects that are necessary or advisable to prepare 13 spaces identified under paragraph (a) of this subsection for use for 14 emergency purposes;
- 15 (c) Identify projects that are necessary or advisable to prepare 16 Redmond Municipal Airport and the Oregon International Port of Coos 17 Bay for use as primary transportation points in an emergency, in-18 cluding use for:
- 19 (A) Receiving assistance from the federal government or other state 20 governments; and
- 21 **(B)** Transporting personnel and equipment within and without this 22 state;
- 23 (d) Identify other projects that are necessary or advisable to in-24 crease the emergency resilience of this state; and
- 25 (e) Assign priorities to and determine funding requirements for 26 projects identified under paragraphs (b), (c) and (d) of this subsection.
- 27 (4) The task force may, in carrying out its duties, consult with any 28 advisors or other persons as the task force deems necessary or advis-29 able.
- 30 (5) A majority of the members of the task force constitutes a quo-31 rum for the transaction of business.

- 1 (6) Official action by the task force requires the approval of a ma-2 jority of the members of the task force.
- 3 (7) The task force shall elect one of its members to serve as chair-4 person.
- 5 (8) If there is a vacancy for any cause, the appointing authority 6 shall make an appointment to become immediately effective.
- 7 (9) The task force shall meet at times and places specified by the 8 call of the chairperson or of a majority of the members of the task 9 force.
- 10 (10) The task force may adopt rules necessary for the operation of the task force.
- 12 (11) The task force shall submit a report on its findings, which may 13 include recommendations for legislation, to the Legislative Assembly 14 in the manner provided by ORS 192.245 no later than September 15, 15 2022.
- 16 (12) The Office of Emergency Management shall provide staff sup-17 port to the task force.
- 18 (13) Members of the task force who are not members of the Legis-19 lative Assembly are not entitled to compensation or reimbursement 20 for expenses and serve as volunteers on the task force.
- 21 (14) All agencies of state government, as defined in ORS 174.111, are 22 directed to assist the task force in the performance of the task force's 23 duties and, to the extent permitted by laws relating to confidentiality, 24 to furnish information and advice the members of the task force con-25 sider necessary to perform their duties.
- 26 (15) As used in this section:
- 27 (a) "Emergency" has the meaning given that term in ORS 401.025.
- (b) "Project" includes, without limitation, infrastructure upgrades, construction or acquisition of real property, acquisition of equipment or other personal property, hiring, training or assignment of personnel and organizational or budgetary modifications.
