SUMMARY

Allows holder of full on-premises sales license to sell and deliver mixed drinks in sealed containers for off-premises consumption. Requires Oregon Liquor Control Commission to adopt rule providing that not more than two mixed drinks may be ordered per substantial food item ordered.

Limits fees that third-party food platform may charge restaurant. Establishes private right of action against third-party food platform for specified violation. Defines “third-party food platform.”

Requires third-party food platform to meet certain requirements within seven days of effective date.

Sunset 60 days after date on which declaration of state of emergency issued by Governor on March 8, 2020, and any extension of declaration, is no longer in effect.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to consumable items; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2020 third special session Act is added**
5 **to and made a part of ORS chapter 471.**

6 **SECTION 2. (1) As used in this section:**

7 (a) **“Mixed drink” means a beverage that is a combination of dis-**
8 **tilled liquor and one or more mixers that is combined on a licensed**
9 **premises and sold in a sealed container for consumption off the li-**
10 **censed premises.**

11 (b) **“Sealed container” means a container:**

12 (A) **With a secure cap or lid that indicates whether the container**
13 **has been opened; and**

1 **(B) That is further defined by the Oregon Liquor Control Commis-**
2 **sion by rule.**

3 **(c) “Third-party food platform” means a website, mobile application**
4 **or other electronic service that:**

5 **(A) Facilitates the order of food and beverages for sale to a con-**
6 **sumer by a licensee; and**

7 **(B)(i) Delivers, or arranges for the delivery of, the order to the**
8 **consumer; or**

9 **(ii) Arranges for the pickup of the order by the consumer from the**
10 **licensee.**

11 **(2)(a) Notwithstanding ORS 471.175, the holder of a full on-premises**
12 **sales license may:**

13 **(A) Sell for off-premises consumption mixed drinks if the mixed**
14 **drink is sold in a sealed container that meets the requirements of**
15 **subsection (3) of this section; and**

16 **(B) Deliver mixed drinks to consumers in this state if the mixed**
17 **drink is delivered in a sealed container that meets the requirements**
18 **of subsection (3) of this section. Notwithstanding ORS 471.405 (3) and**
19 **ORS 471.406, a delivery may be made by a third-party food platform**
20 **on behalf of the holder of a full on-premises license.**

21 **(b) The retail sale or delivery of a mixed drink under this sub-**
22 **section, including a delivery carried out by the licensee through a**
23 **third-party food platform, is subject to rules adopted by the commis-**
24 **sion.**

25 **(3) The cap or lid, and any seal, of the sealed container must be**
26 **affixed to the container in a manner that makes it obvious when the**
27 **cap or lid, and any seal, has been removed or broken. The cap or lid,**
28 **and any seal, may be affixed with the use of tape or other adhesive.**

29 **(4)(a) The commission shall adopt rules to carry out this section.**
30 **The rules adopted under this subsection:**

31 **(A) Must provide that not more than two mixed drinks may be or-**

1 **dered per substantial food item ordered.**

2 **(B) May:**

3 **(i) Define “substantial food item.”**

4 **(ii) Establish additional requirements for the retail sale and delivery**
5 **of mixed drinks for off-premises consumption.**

6 **(b) The commission shall adopt the rules described in this sub-**
7 **section not later than 30 days after the effective date of this 2020 third**
8 **special session Act.**

9 **SECTION 3. (1) As used in this section:**

10 **(a)(A) “Purchase price” means the menu price of an item displayed**
11 **for an online or telephone order.**

12 **(B) “Purchase price” does not include taxes, gratuities or other fees**
13 **that make up the total cost of an item to a consumer.**

14 **(b) “Restaurant” has the meaning given that term in ORS 624.010.**

15 **(c) “Third-party food platform” means a website, mobile application**
16 **or other electronic service that:**

17 **(A) Facilitates the order of food and beverages for sale to a con-**
18 **sumer by a restaurant; and**

19 **(B)(i) Delivers, or arranges for the delivery of, the order to the**
20 **consumer; or**

21 **(ii) Arranges for the pickup of the order by the consumer from the**
22 **restaurant.**

23 **(2)(a) If a restaurant that uses a third-party food platform to facil-**
24 **itate orders of food and beverages for sale to consumers includes with**
25 **an order the option of delivery of the order by the third-party food**
26 **platform, the third-party food platform may not charge the restaurant**
27 **total fees in excess of 10 percent of the purchase price of the order for**
28 **the use of the third-party food platform’s services.**

29 **(b) If a restaurant described in paragraph (a) of this subsection does**
30 **not offer the option of delivery of the order by the third-party food**
31 **platform, the third-party food platform may not charge the restaurant**

1 total fees in excess of five percent of the purchase price of the order
2 for the use of the third-party food platform's services.

3 (c) A third-party food platform may not reduce the rate of com-
4 pensation paid to, or garnish the gratuities of, an individual who
5 makes deliveries of orders to consumers on behalf of the third-party
6 food platform as a result of the requirements of this subsection.

7 (3) An individual who makes deliveries of orders to consumers on
8 behalf of a third-party food platform may bring an action against the
9 third-party food platform for a violation of subsection (2)(c) of this
10 section and may recover damages in the amount of \$500 for each vio-
11 lation.

12 SECTION 4. A third-party food platform, as defined in section 3 of
13 this 2020 third special session Act, shall meet the requirements estab-
14 lished in section 3 (2) of this 2020 third special session Act not later
15 than seven days after the effective date specified in section 6 of this
16 2020 third special session Act.

17 SECTION 5. Sections 2 to 4 of this 2020 third special session Act are
18 repealed 60 days after the date on which the declaration of a state of
19 emergency issued by the Governor on March 8, 2020, and any extension
20 of the declaration, is no longer in effect.

21 SECTION 6. This 2020 third special session Act being necessary for
22 the immediate preservation of the public peace, health and safety, an
23 emergency is declared to exist, and this 2020 third special session Act
24 takes effect on its passage.
