*The pre-COVID alcohol delivery framework distinguished privileges and permissions based on same-day deliveries (order delivered on the same day it is received) and next-day deliveries (order is delivered on any day after the day it is received). Although the current regulatory framework eliminated this distinction, the tables in this workbook uses those terms in order to best illustrate the changes that were implemented.
