SUMMARY

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.

Expands types of expenses, in conformity with federal law, for which use of withdrawal from higher education savings network account is qualified withdrawal for purpose of tax-advantaged treatment. Conforms age limits, applicable to retirement and to commencing payment of benefits, to federal law, for purposes of Public Employees Retirement System. Applies to transactions or activities occurring on or after January 1, 2021, in tax years beginning on or after January 1, 2021.

Takes effect on 91st day following adjournment sine die.

8 Be It Enacted by the People of the State of Oregon:

- 9 **SECTION 1.** ORS 178.300 is amended to read:
- 10 178.300. As used in ORS 178.300 to 178.360:
- 11 (1) "Account" means an individual account established in accordance with
- 12 ORS 178.300 to 178.360.
- 13 (2) "Account owner" means the person who has the right to withdraw
- 14 funds from the account. The account owner may also be the designated ben-
- 15 eficiary of the account.

- (3) "Board" means the Oregon 529 Savings Board established under ORS 1 178.310. 2
- (4) "Designated beneficiary" means, except as provided in ORS 178.350, 3 the individual designated at the time the account is opened as having the right to receive a qualified withdrawal for the payment of qualified higher 5 education expenses, or if the designated beneficiary is replaced in accordance 6 with ORS 178.350, the replacement.

- (5) "Financial institution" means a bank, a commercial bank, a national 8 bank, a savings bank, a savings and loan, a thrift institution, a credit union, 9 an insurance company, a trust company, a mutual fund, an investment firm 10 or other similar entity authorized to do business in this state. 11
- 12 (6) "Higher education institution" means an eligible education institution as defined in section 529(e)(5) of the Internal Revenue Code. 13
- (7) "Internal Revenue Code" means the federal Internal Revenue Code as 14 amended and in effect on December 31, [2018] 2020. 15
- (8) "Member of the family" shall have the same meaning as contained in 16 section 529(e) of the Internal Revenue Code. 17
- (9) "Network" means the Oregon 529 Savings Network established under 18 ORS 178.305. 19
- (10) "Nongualified withdrawal" means a withdrawal from an account that 20 is not a qualified withdrawal. 21
- (11) "Qualified higher education expenses" means tuition and other per-22 mitted expenses as set forth in section 529(e) of the Internal Revenue Code 23 for the enrollment or attendance of a designated beneficiary at a higher ed-24 ucation institution, expenses associated with registered apprenticeship 25 programs described in section 529(c)(8) of the Internal Revenue Code 26 and amounts paid as principal or interest on a qualified education loan 27 to the extent allowed under section 529(c)(9) of the Internal Revenue 28 Code. 29
- (12) "Qualified withdrawal" means a withdrawal made as prescribed under 30 ORS 178.355 and made: 31

- 1 (a) From an account to pay the qualified higher education expenses of the designated beneficiary;
- 3 (b) As the result of the death or disability of the designated beneficiary;
- (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B) or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the extent of the amount of the scholarship, allowance or payment; or
- 8 (d) As a rollover or change in the designated beneficiary described in ORS9 178.350.

SECTION 2. ORS 238.395 is amended to read:

- 238.395. (1)(a) In addition to any other benefits under this chapter, a death 11 12 benefit, provided by contributions of the public employer under ORS 238.225 and, for benefits that accrue on or after July 1, 2020, amounts in the em-13 ployee pension stability account established for the member under ORS 14 238A.353, shall be paid to the beneficiaries designated under ORS 238.390 (1) 15 of a person who is an active or inactive member of the Public Employees 16 Retirement System and who dies as a result of injuries received while em-17 ployed in the service of the public employer or within 120 days after termi-18 nation from service with a participating public employer. A member who is 19 on a leave of absence without pay from employment with a participating 20 public employer has not terminated service with that participating public 21 employer for the purposes of this section. 22
 - (b) The death benefit under this subsection is an amount equal to the amount in the member account of the deceased member at the time of death.
- (c) In the event that a beneficiary has not been named as provided in paragraph (a) of this subsection and ORS 238.390 (1), the death benefit under this subsection shall be paid in the manner provided for payment of money credited to the member account of the member in ORS 238.390 (2).
- (d) The beneficiary designated under paragraph (a) of this subsection and ORS 238.390 (1) may elect to receive the amount payable in actuarially determined monthly payments for the life of such beneficiary as long as such

- monthly payments, plus the monthly amount if elected under ORS 238.390 (3), are at least \$200.
- (e) Interest upon the death benefit provided by this subsection accrues until the date that the benefit is distributed. The Public Employees Retirement Board shall establish procedures for computing interest to be credited on the benefit for the period between the date of death and date of distribution.

- (2)(a) If a member of the system dies while employed in the service of a participating public employer or within 120 days after termination from service with a participating public employer and the member's spouse is the member's beneficiary under ORS 238.390, the member's spouse may elect to receive the benefit provided under this subsection in lieu of the death benefits provided under ORS 238.390 and subsection (1) of this section.
- 14 (b) The member's spouse must notify the board in writing of an election 15 under this section no later than 60 days after the date of death of the mem-16 ber.
- 17 (c) The death benefit to be paid under this subsection is for the life of the 18 member's spouse and is the actuarial equivalent of 50 percent of the service 19 retirement allowance that would otherwise have been paid to the deceased 20 member, which shall be calculated:

- 28 of final average salary multiplied by the number of years of retirement credit
- 29 attributable to service as other than a police officer or firefighter.
- 30 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the an-
- 31 nual benefit payable to a member under the pension program and under any

(1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible employee who leaves a qualifying position for the purpose of performing service in the uniformed services, and who subsequently returns to employment with a participating public employer with reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2) of this section.
- (2) The board shall adopt rules establishing benefits and service credit for any period of service in the uniformed services by an employee described in subsection (1) of this section. For the purpose of adopting rules under this subsection, the board shall consider and take into account all federal law relating to benefits and service credit for any period of service in the uniformed services, including 26 U.S.C. 414(u), as in effect on December 31, [2018] 2020. Benefits and service credit under rules adopted by the board pursuant to this subsection may not exceed benefits and service credit required under federal law for periods of service in the uniformed services.

238A.170. (1) An active member of the pension program who is [70-1/2] **72**30 years of age or older must retire not later than April 1 of the calendar year
31 following the calendar year in which the member terminates employment

- with all participating public employers. An inactive member of the pension program must retire not later than April 1 of the calendar year following the calendar year in which the member attains [70-1/2] 72 years of age.
- (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the 4 entire interest of a member of the pension program must be distributed over 5 a time period commencing no later than the required beginning date set forth 6 in subsection (1) of this section, and must be distributed in a manner that 7 satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) 8 and regulations implementing that section, as in effect on [December 31, 9 2018] January 1, 2020. The Public Employees Retirement Board shall adopt 10 rules implementing those minimum distribution requirements. 11
- 12 **SECTION 7.** ORS 238A.230 is amended to read:
- 238A.230. (1) If a member of the pension program who is vested dies before the member's effective date of retirement, the Public Employees Retirement Board shall pay the death benefit provided for in this section to:
- 16 (a) The spouse of the member to the extent not provided to a former 17 spouse in accordance with a judgment or order under ORS 238.465;
- 18 (b) The former spouse of the member as provided in a judgment or order 19 under ORS 238.465; or
- 20 (c) Any other person who is constitutionally required to be treated in the 21 same manner as a spouse for the purpose of retirement benefits.
- (2)(a) The death benefit to be paid under this section shall be for the life of the spouse, former spouse or other person who is constitutionally required to be treated in the same manner as a spouse, and shall be the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the deceased member.

- (B) As if the member became an inactive member on the date of death and thereafter retired at the earliest retirement date if the member dies before the earliest retirement date for the member under ORS 238A.165.
- (3) The death benefit provided under this section is first effective on the first day of the month following the date of death of the member. The surviving spouse, former spouse or other person entitled to the death benefit may elect to delay payment of the death benefit, but payment must commence no later than December 31 of the calendar year in which the member would have reached [70-1/2] 72 years of age.
 - (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death benefits under the pension program must comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on [December 31, 2018] January 1, 2020. The board shall adopt rules implementing those minimum distribution requirements.

SECTION 8. ORS 238A.370 is amended to read:

238A.370. Notwithstanding any other provision of ORS 238A.300 to 17 238A.415, the annual addition to the employee and employer accounts of a 18 member of the individual account program for a calendar year, together with 19 the annual additions to the accounts of the member under any other defined 20 21 contribution plan maintained by the participating public employer for a calendar year, may not exceed the lesser of \$40,000, or 100 percent of the 22 member's compensation for that calendar year. For purposes of this section, 23 "annual addition" has the meaning given that term in 26 U.S.C. 415(c)(2), 24 as in effect on December 31, [2018] **2020**, and "compensation" has the meaning 25 given the term "participant's compensation" in 26 U.S.C. 415(c)(3), as in ef-26 fect on December 31, [2018] 2020. The Public Employees Retirement Board 27 shall adopt rules for the administration of this limitation, including adjust-28 ments in the annual dollar limitation to reflect cost-of-living adjustments 29 authorized by the Internal Revenue Service. 30

- 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS 238A.165, a member of the individual account program shall receive in a lump sum the amounts in the member's employee account, rollover account and employer account to the extent the member is vested in those accounts under ORS 238A.320.
- (2) In lieu of a lump sum payment under subsection (1) of this section, a 6 member of the individual account program may elect to receive the amounts 7 in the member's employee account and employer account, to the extent the 8 member is vested in those accounts under ORS 238A.320, in substantially 9 equal installments paid over a period of 5, 10, 15 or 20 years, or over a period 10 that is equal to the anticipated life span of the member as actuarially de-11 12 termined by the Public Employees Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event may the period 13 selected by the member exceed the time allowed by the minimum distribution 14 requirements described in subsection (5) of this section. The board shall by 15 rule establish the manner in which installments will be adjusted to reflect 16 investment gains and losses on the unpaid balance during the payout period 17 elected by the member under this subsection. The board by rule may estab-18 lish minimum monthly amounts payable under this subsection. The board 19 may require that a lump sum payment, or an installment schedule different 20 21 than the schedules provided for in this subsection, be used to pay the vested amounts in the member's accounts if those amounts are not adequate to 22 generate the minimum monthly amounts specified by the rule. 23
 - (3) A member of the individual account program electing to receive installments under subsection (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies before all amounts in the employee and vested employer accounts are paid, all remaining installment payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary may elect to receive a lump sum distribution of the remaining amounts.
 - (4) A member who is entitled to receive retirement benefits under ORS

- 1 chapter 238 may receive vested amounts in the member's employee account,

- 27 (8) "Covered individual" means any one of the following who qualifies to

- 29 (a) An eligible employee;
- 30 (b) A self-employed individual; or
- 31 (c) An employee of a tribal government.

- 1 (9) "Domestic partner" means an individual joined in a domestic partner-
- 2 ship.
- 3 (10) "Domestic partnership" has the meaning given that term in ORS
- 4 106.310.
- 5 (11) "Eligible employee" means:
- 6 (a)(A) An employee who has earned at least \$1,000 in wages during the
- 7 base year; or
- 8 (B) If an employee has not earned at least \$1,000 in wages during the base
- 9 year, an employee who has earned at least \$1,000 in wages during the alter-
- 10 nate base year; and
- 11 (b) Who may apply for paid family and medical leave insurance benefits
- 12 under ORS 657B.015.
- 13 (12) "Eligible employee's average weekly wage" means an amount calcu-
- 14 lated by the Director of the Employment Department by dividing the total
- 15 wages earned by an eligible employee during the base year by the number
- 16 of weeks in the base year.

- (A) An individual performing services for an employer for remuneration

- 23 (B) A participant in a work training program administered under a state

- 21 placement benefits that are available to a covered individual under ORS
- 22 657B.050 or under the terms of an employer plan approved under ORS
- 23 657B.210, for family leave, medical leave or safe leave.
- 24 (17)(a) "Family leave" means leave from work taken by a covered indi-
- 25 vidual:
- 26 (A) To care for and bond with a child during the first year after the
- 27 child's birth or during the first year after the placement of the child through
- 28 foster care or adoption; or
- 29 (B) To care for a family member with a serious health condition.
- 30 (b) "Family leave" does not mean:

- 6 (23) "Serious health condition" has the meaning given that term in ORS 7 659A.150.
- 8 (24) "Third party administrator" means a third party that enters into an 9 agreement with the Director of the Employment Department to implement
- 10 and administer the paid family and medical leave program established under
- 11 this chapter.
- 12 (25) "Tribal government" has the meaning given that term in ORS 13 181A.680.
- 14 (26) "Wages" has the meaning given that term in ORS 657.105.
- SECTION 30. (1) Except as provided in subsections (2) and (3) of this
- section, the amendments to statutes by sections 1 to 29 of this 2021
- 17 Act apply to transactions or activities occurring on or after January
- 18 1, 2021, in tax years beginning on or after January 1, 2021.
- 19 (2) The effective and applicable dates, and the exceptions, special
- 20 rules and coordination with the Internal Revenue Code, as amended,

 - (c) Any changes required because of the amendments to ORS 178.300, 305.230, 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1 and 14 to 26 of this 2021 Act, for a tax year beginning before January 1, 2021, shall be made by filing an amended return within the time prescribed by law.
- (d) If a taxpayer fails to file an amended return under paragraph 17 (c) of this subsection, the Department of Revenue shall make any 18 changes under paragraph (c) of this subsection on the return to which 19 the changes relate within the period specified for issuing a notice of 20 21 deficiency or claiming a refund as otherwise provided by law with respect to that return, or within one year after a return for a tax year 22 beginning on or after January 1, 2021, and before January 1, 2022, is 23 filed, whichever period expires later. 24
 - SECTION 31. This 2021 Act takes effect on the 91st day after the date on which the 2021 regular session of the Eighty-first Legislative Assembly adjourns sine die.
