Public Hearing

HB 2003

Requires Oregon Department of Administrative Services to develop methodology to conduct regional housing needs analysis and, for certain cities and Metro, to inventory existing housing stock and to establish housing shortage analysis.

HB 3384

Limits reasons counties may deny expansion of certain schools on land zoned for exclusive farm use.

HB 3372 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 3-28-2019 MEETING: Requires State Department of Agriculture to adopt rules governing processing and sale of beef and lamb that does not travel in interstate commerce.

HB 3401

Abolishes Oregon Orchardgrass Seed Producers Commission on later of July 1, 2019, or one day after effective date of Act.

HB 2579 **

**Subsequent Referral(s) to Ways and Means

Expands types of entities that may receive grant from Farm-to-School Grant Program to purchase food produced or processed in state.

HB 2435

Makes permanent 2018 law sunsetting April 15, 2020, that allows guest ranches to be established on lands zoned for exclusive farm use in eastern Oregon.

HB 2844

Allows facilities for processing farm products under 2,500 square feet on lands zoned for exclusive farm use without regard to siting standards.

HB 2573

Removes cranberry farms from definition of "high-value farmland.".

AGENDA (Cont.) **April 2, 2019**

**Subsequent Referral(s) to Revenue HB 3024 **

Prohibits county from considering property tax classification of dwellings that were previously removed, destroyed, demolished or converted to nonresidential uses when reviewing application for replacement dwelling on lands zoned for exclusive farm use.

HB 2577

Requires three-year waiting period for annexation of property that is zoned to allow residential use as permitted use in zone and is in residential use when annexation is initiated.

HB 2109

Requires that, in election proposing annexation, votes from city and territory to be annexed be counted separately to determine separate majorities if territory to be annexed includes 100 acres or more.

Extends sunset date of pesticide use reporting system.

HB 2816 **

**Subsequent Referral(s) to Ways and Means Establishes Task Force on Integrated Pest Management to study coordination of integrated pest management in public universities and state agencies.
