HB 2211

Directs Department of Human Services to study issues and identify barriers relating to employment of persons with disabilities and report results of study to interim committees of Legislative Assembly related to human services on or before February 1, 2021.

HB 2212 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Oregon Department of Administrative Services for purposes of providing financial assistance to state agencies that provide workplace accommodations for employees with disabilities.

HB 2886

Modifies law regarding requirement that public employer grant preference to veteran or disabled veteran in selection process for civil service position.

Work Session

HB 2312

Requires seller of property to disclose whether property is identified by FEMA as Special Flood Hazard Area or whether flood insurance is required by local ordinance or in order to obtain federally regulated loan.

HB 2133 **

**Subsequent Referral(s) to Revenue

Extends sunset for tax credit for pension income.

HB 2660

Removes prohibition on payment of unemployment insurance benefits to nonprofessional employees of educational institution providing facilities or janitorial services for weeks of unemployment commencing during period between two successive academic years or terms.

HB 2089

Prohibits title loan lender and payday loan lender from making loan to consumer until seven days after consumer has fully repaid outstanding title loan or payday loan.

HB 2769

Permits contracting agency, in conducting procurement for architectural, engineering, photogrammetric mapping, transportation planning and land surveying services, to consider pricing policies, proposals and other pricing information as part of screening and selection of consultants in specified circumstances.
