Public Hearing

- HB 2023
Directs State Board of Education to ensure that academic content standards for certain subjects include sufficient instruction on histories, contributions and perspectives of certain classifications of individuals.
- HB 2224 ** **Subsequent Referral(s) to Student Success
Directs Department of Education to distribute grants for improving student outcomes by supporting social, emotional, mental and physical health needs of students.
- HB 2441 ** **Subsequent Referral(s) to Student Success
Requires school districts to provide coordinated comprehensive school counseling program.
- HB 2940 ** **Subsequent Referral(s) to Student Success
Establishes pilot program for purpose of increasing number of public school students who are served by school social workers.

Work Session

- HB 2026 ** **Subsequent Referral(s) to Student Success
Extends sunset on pilot program to decrease rates of school absenteeism by using trauma-informed approaches to education, health services and intervention strategies.

Please note: HB 2358 is being scheduled for a work session solely for the purpose of moving it without recommendation, rescinding the referral to the Joint Committee on Student Success, and requesting referral to the House Committee on Rules.

- HB 2358 ** **Subsequent Referral(s) to Student Success
Provides grants to counties that received Secure Rural Schools Program payments in calendar year 2008 equal to at least 30 percent of all moneys deposited into county general fund.
