Work Session

- HB 2322
CARRIED OVER FROM THE 04-02-2019 AGENDA: Requires Land Conservation and Development Commission to amend statewide land use planning goals related to energy to incorporate development of renewable energy facilities and reduction of greenhouse gas emissions and to match state energy policies.
- HB 2496
CARRIED OVER FROM THE 04-02-2019 AGENDA: Includes battery storage in definition of "green energy technology." Defines "total contract price." Permits contracting agency, as alternative to including green energy technology in construction, reconstruction or major renovation of public building, to make expenditure to improve energy use efficiency in public building.
- HB 2509
CARRIED OVER FROM THE 04-02-2019 AGENDA: Prohibits use of single-use checkout bags except in certain cases.
- HB 2860 **
CARRIED OVER FROM THE 04-02-2019 AGENDA: Requires Oregon Health Authority to analyze ground water contaminant data and provide education in areas with ground water contaminant problems. **Subsequent Referral(s) to Ways and Means
- HB 2883 **
CARRIED OVER FROM THE 04-02-2019 AGENDA: Prohibits food vendor from using polystyrene container in selling, offering for sale, serving or dispensing prepared food to public. **Subsequent Referral(s) to Ways and Means
- HB 3055
CARRIED OVER FROM THE 04-02-2019 AGENDA: Prohibits sale of mattress or children's product that incorporates or bears specified chemicals unless person affixes or attaches warning to mattress or children's product.
- HB 3094 **
CARRIED OVER FROM THE 04-02-2019 AGENDA: Establishes Home Weatherization, Retrofit and Affordability Program for Housing and Community Services Department to provide incentive payments to construction contractors undertaking energy improvement projects on residential structures. **Subsequent Referral(s) to Ways and Means
- HB 2007 **
Directs Environmental Quality Commission to adopt by rule diesel engine emission standards for medium-duty trucks and heavy-duty trucks. **Subsequent Referral(s) to Ways and Means

April 4, 2019

- HB 3062 ** **Subsequent Referral(s) to Revenue
Extends sunset date for exemption from use fuel tax for diesel fuel blended with at least 20 percent biodiesel derived from used cooking oil.
- HB 3182
Requires permit for construction, installation or operation of system for on-site treatment and reuse of nonpotable water.
- HB 3274
Requires eight percent of electricity sold in this state by each electric company that makes sales to 25,000 or more retail electricity consumers to be generated by small-scale renewable energy facilities or certain biomass facilities.
- HB 3326 ** **Subsequent Referral(s) to Ways and Means
Declares harmful algal blooms to be menace to public health and welfare.

Public Hearing and Possible Work Session

- HB 2494
CARRIED OVER FROM THE 04-02-2019 AGENDA: Extends operation of public purpose charges until January 1, 2036.
- HB 3141
CARRIED OVER FROM THE 04-02-2019 AGENDA: Modifies and adds laws related to electric vehicle charging stations.
- HB 3408
CARRIED OVER FROM THE 04-02-2019 AGENDA: Appropriates moneys from General Fund to Department of Environmental Quality for deposit in Residential Solid Fuel Heating Air Quality Improvement Fund to fund community efforts to promote economic development and improve public health by reducing emissions from solid fuel burning devices that burn wood.
- HB 3407
Authorizes electric companies that are subject to renewable portfolio standards to offer to purchase qualifying electricity generated by certain hydroelectric facilities.

Note change: HB 3157 has been removed.
