Public Hearing

- HB 2011
Requires specified professional regulatory boards to require persons authorized to practice professions regulated by board to complete cultural competency continuing education.
- HB 3397 ** **Subsequent Referral(s) to Ways and Means
Requires Oregon Health Authority to contract with person to be purchasing agent to assist authority in purchasing prescription drugs for medical assistance recipients.
- HB 3262 ** **Subsequent Referral(s) to Revenue
CARRIED OVER FROM 03/28/2019 AGENDA: Imposes assessment on large employers with employees who receive or who have minor children who receive certain types of public assistance in this state, in amount equal to public assistance paid.

Public Hearing and Work Session

- HB 3231
Authorizes Health Licensing Office to issue license to practice genetic counseling to qualified applicant.
- HB 3279 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM 03/28/2019 AGENDA: Requires Oregon Health Authority to establish uniform payment amounts applicable to medical assistance payments to providers of substance use disorder services and providers of mental health treatment.
- HB 3095 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM 03/28/2019 AGENDA: Directs Department of Human Services to increase fee-for-service rate for behavioral health providers participating in medical assistance programs.

Work Session

- HB 2269
Requires Oregon Health Authority, in consultation with stakeholders, to propose to interim committees of Legislative Assembly related to health, by January 1, 2020, long term solutions to financing health care in Oregon.

AGENDA (Cont.) April 2, 2019

- HB 2600 ** **Subsequent Referral(s) to Ways and Means
Requires long term care facilities and residential care facilities providing care to six or more residents to adopt specified protocols and procedures regarding preventing and reporting disease outbreaks.
- HB 2303
CARRIED OVER FROM 03/28/2019 AGENDA: Deletes requirement that pseudoephedrine be classified as Schedule III controlled substance.
- HB 2678
Subject to exceptions, allows Oregon Health Authority to require prior authorization for prescription drugs, other than mental health drugs, that are not listed on Practitioner-Managed Prescription Drug Plan and that are reimbursed on fee-for-service basis.
- HB 3273 ** **Subsequent Referral(s) to Ways and Means
Directs each manufacturer of prescription drugs that are sold within this state to develop and implement drug take-back program for purpose of collecting from individuals and nonbusiness entities prescription drugs for disposal.
- HB 3074
Limits rate review process that invites public comment to process for approving rates for health benefit plans.
- HB 3076
Requires nonprofit hospitals and hospital systems to establish financial assistance policies meeting specified criteria.
- HB 2658 ** **Subsequent Referral(s) to Ways and Means
Requires manufacturer of prescription drugs to report to Department of Consumer and Business Services planned increase in price of certain prescription drugs at least 60 days before date of increase.
- HB 2692
CARRIED OVER FROM 03/28/2019 AGENDA: Requires Pharmacy and Therapeutics Committee to publish on website of Oregon Health Authority within seven days recommendations concerning Practitioner-Managed Prescription Drug Plan.
- HB 3165 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM 03/28/2019 AGENDA: Requires Oregon Health Authority to provide planning grants to 10 school districts or education service districts to evaluate community needs for school-based health services.

Please note: the following bills are scheduled for work sessions solely for the purpose of moving them without recommendation to other committees.

- HB 3075 ** **Subsequent Referral(s) to Ways and Means
Permits duplicate health benefit plan coverage for public employees.
- HB 2035
Reestablishes Mental Health Clinical Advisory Group in Oregon Health Authority to continue development of evidence-based algorithms for prescription drug treatment of mental health disorders.
- HB 2266
Requires Oregon Health Policy Board to study changes in health care coverage in Oregon since implementation of Patient Protection and Affordable Care Act and report results of study to interim committees of Legislative Assembly related to health.
- HB 3250 ** **Subsequent Referral(s) to Ways and Means
Establishes Reporting Relief and Medicaid Transparency Task Force.
- HB 3267
Requires Oregon Health Authority to research innovative approaches to delivery and financing of health care in other states and countries and report to interim committees of Legislative Assembly related to health on any practices that could be implemented in this state.
- HB 3278 ** **Subsequent Referral(s) to Revenue
Allows additional weight for purpose of State School Fund distributions for students in drug or alcohol treatment programs that meet certain requirements.
- HB 3307 ** **Subsequent Referral(s) to Ways and Means
Assesses fee on emergency medical services providers and uses fee to increase reimbursement paid by Oregon Health Authority for emergency medical services transports.

- HB 3331 ** **Subsequent Referral(s) to Ways and Means
Allows eligible employee who declines coverage in health benefit plan offered by Oregon Educators Benefit Board or Public Employees' Benefit Board and who is enrolled as spouse or family member in another health benefit plan offered by Oregon Educators Benefit Board or Public Employees' Benefit Board to be paid employer contribution for plan that was declined.
- HB 2706 ** **Subsequent Referral(s) to Ways and Means
Establishes COFA Dental Program in Oregon Health Authority to provide dental care to low-income citizens of Pacific Islands in Compact of Free Association who reside in Oregon and lack access to affordable dental coverage.

Note change: HB 3311, HB2267, and HB 2667 have been removed from the agenda. HB 3279, HB 3095, HB 2692, HB 3165, HB 2706, and HB 3262 have been added to the agenda.
