Public Hearing and Possible Work Session

HB 2960

Requires pharmacist to dispense controlled substance in Schedule II of federal Controlled Substances Act in lockable vial.

Work Session

HB 2986 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM 04/04/2019 AGENDA: Requires Oregon Health Authority and coordinated care organizations to partner with regional health equity coalitions in addressing health disparities for communities of color.

HB 2217

Prohibits anyone other than patient from administering medication to end patient's life in humane and dignified manner.

HB 2717 **

**Subsequent Referral(s) to Ways and Means

Requires Oregon Health Authority to take steps to limit cost to hospitals, ambulatory surgical centers and extended stay centers for compiling and reporting records and data.

HB 2935 **

**Subsequent Referral(s) to Ways and Means

Requires pharmacies to notify person to whom prescription drug is dispensed of availability of prescription reader.

HB 2017

Directs Oregon Health Authority to study health care in this state.

HB 2627 **

**Subsequent Referral(s) to Ways and Means

Requires Oregon Health Authority to operate peer managed recovery centers in cities in this state with populations of 100,000 or more to provide peer mentor support and peer support services to individuals in recovery from addiction.

HB 2600 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM 04/04/2019 AGENDA: Requires long term care facilities and residential care facilities providing care to six or more residents to adopt specified protocols and procedures regarding preventing and reporting disease outbreaks.

- HB 2678
CARRIED OVER FROM 04/04/2019 AGENDA: Subject to exceptions, allows Oregon Health Authority to require prior authorization for prescription drugs, other than mental health drugs, that are not listed on Practitioner-Managed Prescription Drug Plan and that are reimbursed on fee-for-service basis.
- HB 3076
CARRIED OVER FROM 04/04/2019 AGENDA: Requires nonprofit hospitals and hospital systems to establish financial assistance policies meeting specified criteria.
- HB 2011
CARRIED OVER FROM 04/04/2019 AGENDA: Requires specified professional regulatory boards to require persons authorized to practice professions regulated by board to complete cultural competency continuing education.
- HB 3397 **
CARRIED OVER FROM 04/04/2019 AGENDA: Requires Oregon Health Authority to contract with person to be purchasing agent to assist authority in purchasing prescription drugs for medical assistance recipients. **Subsequent Referral(s) to Ways and Means
- HB 2012 **
CARRIED OVER FROM 04/04/2019 AGENDA: Allows individuals who do not qualify for medical assistance or premium tax credits under Affordable Care Act to enroll in coordinated care organizations by paying premiums that cover actuarial value of health services. **Subsequent Referral(s) to Ways and Means
- HB 2185
CARRIED OVER FROM 04/04/2019 AGENDA: Imposes new requirements on pharmacy benefit managers registered in this state.
- HB 2840
CARRIED OVER FROM 04/04/2019 AGENDA: Establishes prohibitions for registered pharmacy benefit managers.
- HB 2658 **
CARRIED OVER FROM 04/04/2019 AGENDA: Requires manufacturer of prescription drugs to report to Department of Consumer and Business Services planned increase in price of certain prescription drugs at least 60 days before date of increase. **Subsequent Referral(s) to Ways and Means
- HB 3273 **
CARRIED OVER FROM 04/04/2019 AGENDA: Directs each manufacturer of prescription drugs that are sold within this state to develop and implement drug take-back program for purpose of collecting from individuals and nonbusiness entities prescription drugs for disposal. **Subsequent Referral(s) to Ways and Means
- HB 2690
CARRIED OVER FROM 04/04/2019 AGENDA: Establishes right of consumer to be educated about ways to reduce cost of prescription drugs.
