Public Hearing and Work Session

- SB 824 A
Allows Oregon Board of Dentistry to accept results of national standardized examinations under specified circumstances when determining fitness of applicant to practice dentistry.
- SB 835 A
Allows dentist to advertise practice in specialty area of dentistry.
- SB 133 A
Prohibits provider of substance abuse, problem gambling or mental health services and support from accepting or paying patient referral bonus or falsely advertising individual's need for services or support or individual's eligibility to participate in medical assistance program.
- SB 665 A
Directs State Board of Education to adopt rules for administration of naloxone or any similar medication designed to rapidly reverse overdose of opioid drug.

Work Session

- SB 1027
CARRIED OVER FROM THE 05/16/2019 AGENDA: Allows certain health care practitioner who receives needlestick injury during provision of medical care to patient who is unconscious or otherwise unable to consent to test patient for human immunodeficiency virus for purpose of determining necessary course of treatment for health care practitioner.

Public Hearing and Work Session

- SB 1039 A
CARRIED OVER FROM THE 05/16/2019 AGENDA: Authorizes appointment of health care advocate to make health care decisions for individual with developmental disability receiving services through individualized written service plan if individual does not have guardian or health care representative.

- SB 26
CARRIED OVER FROM THE 05/16/2019 AGENDA:Directs Director of the Oregon Health Authority or director's designee to discharge employee at facility under jurisdiction of authority if it has been substantiated that employee physically or sexually abused patient or client.

Work Session

- SB 910 A
CARRIED OVER FROM THE 05/16/2019 AGENDA:Requires retail or hospital pharmacy to provide written notice in conspicuous manner of availability of naloxone at pharmacy.
- SB 29 A
CARRIED OVER FROM THE 05/16/2019 AGENDA:Modifies terms "venereal disease" and "sexually transmitted disease" to "sexually transmitted infection." Clarifies hearings procedure for certificates of need for certain health care facilities.
- SB 1041 A
CARRIED OVER FROM THE 05/16/2019 AGENDA:Grants to Oregon Health Authority powers to regulate financial condition of coordinated care organizations that align with powers of Department of Consumer and Business Services to regulate domestic insurers.

Note change: SB 1027, SB 1039 A, SB 26, SB 910 A, and SB 1041 A have been carried over from the 05/16/2019 agenda. SB 29 A has been added to the agenda.
