Possible Reconsideration and Work Session HB 3116 **

**Subsequent Referral(s) to Revenue

**Subsequent Referral(s) to Revenue

Requires counties with population of 650,000 or more to use proceeds from sale of foreclosed property to reimburse municipal liens against property for utilities improvements or seismic rehabilitation.

Please note: HB 3116 is being scheduled for a possible reconsideration and work session for the purpose of reconsidering the subsequent referral to the House Committee on Revenue.

Possible Work Session

HB 3184 **

Directs Department of Revenue, in consultation with Housing and Community Services Department, to conduct study of imposition and administration of residential vacancy tax to fund affordable housing, and to report findings to interim legislative committees related to revenue and housing on or before September 15, 2020.

Please note: HB 3184 is being scheduled for a possible work session solely to move it without recommendation to the House Committee on Revenue.

HB 2626 **

Permits Office of Child Care to consider any information obtained by office when reviewing enrollment in Central Background Registry.

HB 3383 **

**Subsequent Referral(s) to Ways and Means

Directs Department of Human Services to develop pilot program contracting with Yamhill County for provision of community-based child welfare services.

HB 2360 **

Establishes Task Force on Use of Surplus Public Lands for Housing.

CARRIED OVER FROM THE 4/3/2019 1:00 P.M. AGENDA: Requires property owner subject to affordability restriction to provide more notice to qualified purchasers before restrictions expire.

HB 3208

CARRIED OVER FROM THE 4/3/2019 1:00 P.M. AGENDA: Directs Department of Human Services to study and develop two-year and five-year plans for department to provide comprehensive funding for child welfare services, ensure adequate in-state services for children's therapeutic care and request sufficient funding for high level staff.

Directs Department of Human Services to distribute \$1 million to Center for the Prevention of Abuse and Neglect to conduct Oregon Child Abuse Prevalence Study.

Changes name of office of Long Term Care Ombudsman to office of Long Term Care Ombudsmen.

HB 3270

Increases number of adults permitted to reside in adult foster home from five to seven.
