On Human Services Bills in Ways and Means

SB 745 A

Directs Department of Human Services to conduct annual in-person case planning with ward 14 years of age or older during which department informs ward that ward is eligible for transition services and provides ward with assistance in accessing transition services, if applicable.

SB 832 A

Declares purpose of Critical Incident Review Teams.

SB 475 A

CARRIED OVER FROM THE 5/13/2019 AGENDA: Permits school district to provide abbreviated school day program to foster youth student only if student's foster parent is provided opportunity to participate in decision and school district provides certain written information to foster parent.

- SB 493 A
CARRIED OVER FROM THE 5/13/2019 AGENDA: Establishes Oregon Human Rights Commission to safeguard dignity and basic human rights of individuals who have intellectual or developmental disabilities.
- SB 20 A
CARRIED OVER FROM THE 5/13/2019 AGENDA: Consolidates eligibility for services to children and adults with developmental disabilities.
- SB 490 A
Modifies definition of "exempt prohibited individual." Prohibits permanently from providing child care individuals who have been subject of substantiated report of child abuse in which victim suffered serious harm or death and individuals who are required to report as sex offenders.
- SB 917 A
Prohibits long term care facilities, residential facilities, adult foster homes, child care facilities, child-caring agencies, foster homes, youth care centers, youth offender foster homes or other entities that are licensed, certified or registered to provide care to children, youth, individuals with disabilities or older adults from interfering with good faith disclosure of information by employees or volunteers about abuse or mistreatment of individuals cared for by entity, violations of state or federal laws or other practice that threatens health and safety of individuals cared for by entity, to regulatory agencies, law enforcement authorities, persons acting on behalf of individual and other specified individuals.
- SB 543
Authorizes formation of children's service districts.
