#### Public Hearing

HB 2466

Requires homeowners associations and condominium unit owners associations to be audited by certified public accountant at least once every three years if annual assessments exceed \$500,000.

HB 2485

Establishes procedures for adoption of restated declaration, restated assignment of use of limited common elements and restated bylaws by condominium association.

HB 2286

Places civil forfeiture proceeds used to fund scholarship for children of deceased or disabled public safety officers in account established or designated by State Treasurer in Oregon 529 Savings Network, rather than in Oregon 529 College Savings Plan Subaccount.

HB 3064 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Expands membership of Justice Reinvestment Program Grant Review Committee.

#### Work Session

HB 2401

Modifies definition of "officer-initiated pedestrian stop" for purposes of profiling data collection by removing requirement that stop result in citation, arrest or search.

HB 2227

Modifies list of mandatory reporters of suspected child abuse to include animal control officers.

HB 2500

Provides private right of action to recover for expenses in relation to veterinary care for abused domestic animal.
