HB 2241 ** **Subsequent Referral(s) to Ways and Means
Authorizes Chief Justice of the Supreme Court to impose fees on public bodies for use of certain electronic court services.

HB 2462
Directs court to, at time of arraignment, notify defendant that status as servicemember may make defendant eligible for treatment programs, specialty courts or sentencing mitigation.

HB 2585
Allows Chief Medical Examiner to complete and file report of death for person missing in wilderness and presumed dead.

HB 2598
Permits creation of noncharitable business purpose trust.

HB 2239 ** **Subsequent Referral(s) to Ways and Means
Increases number of circuit court judges in certain judicial districts.

HB 2328 ** **Subsequent Referral(s) to Ways and Means
Modifies culpable mental state for crime of unauthorized use of a vehicle when person takes, operates, exercises control over or otherwise uses vehicle, boat or aircraft without consent of owner.

HB 2014
CARRIED OVER FROM 3/18/2019 AGENDA: Restricts limitation on award of noneconomic damages to claims in actions for wrongful death.
