#### **Work Session**

HB 2505, HB 3299, and HB 3329 heard for the sole purpose of referral to the House Committee on Rules without recommendation:

HB 2505

CARRIED OVER FROM 4/2/2019 AGENDA: Requires owner or possessor of firearm to secure firearm with trigger or cable lock or in locked container except in specified circumstances.

HB 3299

CARRIED OVER FROM 4/2/2019 AGENDA: Directs Department of State Police to conduct study on reporting of attempted unlawful firearm transfers and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

HB 3329

CARRIED OVER FROM 4/2/2019 AGENDA: Allows gun dealer or person transferring firearms, firearm accessories, firearm components, ammunition or ammunition components for purchase at gun show, or business engaged in repairing or servicing firearms to establish minimum age of 21 years for such purchases, repairs or services.

### **Public Hearing and Work Session**

HB 2601

Limits guardian's authority to limit protected person's preferred associations with third parties.

HB 2849

Heightens standards for taking child into protective custody with or without court order.

HB 2982

Authorizes local officials to determine whether residential properties subject to ongoing foreclosure or forfeiture proceedings are abandoned.

HB 3216

Creates offense of unlawfully summoning a police officer.

HB 3360 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Provides that bonds may be issued under Article XI-Q of Oregon Constitution if Chief Justice of Supreme Court determines that remodeling, renovation or expansion of court facilities is necessary or desirable.

#### **Work Session**

HB 2096

Permits court to withhold award all or part of attorney fees to person who prevails against Oregon Government Ethics Commission in contested case proceeding if court finds that commission's action was substantially justified or that special circumstances exist.

HB 2244 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes CourtCare Fund and appropriates moneys in fund to Department of Education for distribution to counties to operate CourtCare programs.

HB 2459

Provides procedure for certain persons that hold interest in real property to request and obtain lien information statement that shows amounts necessary to satisfy encumbrance against real property from other person that holds encumbrance.

HB 2480

Creates exception to prohibition on recording communications for person who records conversation during or regarding commission of offense against person.

HB 2842

Directs Center for Health Statistics to enter name of parent on original record of live birth when paternity or parentage has been determined under certain circumstances.

HB 2932

Prohibits court from inquiring into defendant's immigration status or requiring defendant to disclose defendant's immigration status at time of plea or at any other time during criminal proceeding.

HB 3005

Modifies laws related to ignition interlock devices.

HB 3117

Extends period for filing restraining order under Family Abuse Prevention Act to two years from 180 days after date of abuse.

HB 3201

Provides that agreement for deferred resolution of criminal cases may not contain requirement that defendant enter plea of guilty or no contest.

HB 3249

Provides that client has right to privately communicate with lawyer and representative of lawyer.

HB 3337

Prohibits police officer from conducting or participating in activities intended to determine whether person has paid certain user charges, fees or tolls imposed by mass transit district.

HB 2882

Allows cause of action against patent holder or licensed manufacturer for genetically engineered organism present or land without permission of owner or lawful occupant.

HB 2882 is heard for the sole purpose of referral to the House Committee on Rules without recommendation
