## **Public Hearing and Work Session**

HJR 10 \*\*

\*\*Subsequent Referral(s) to Rules

Proposes amendment to Oregon Constitution to allow juries to impose verdicts in criminal cases only by unanimous agreement.

HB 2615

Repeals statutory authority for nonunanimous jury verdicts in criminal trials.

HB 3419

Prohibits prosecuting attorney from conditioning plea offer on waiver of specified rights, eligibilities and legal challenges.

HB 3224

Directs district attorney of each county to, no later than December 1, 2020, develop and adopt policies relating to discovery, charging decisions and case disposition and to make policies available to public on website.

HB 3289

Directs Department of Corrections to conduct study on correctional facility siting process and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

#### **Work Session**

HB 2096

Permits court to withhold award all or part of attorney fees to person who prevails against Oregon Government Ethics Commission in contested case proceeding if court finds that commission's action was substantially justified or that special circumstances exist.

HB 2244 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes CourtCare Fund and appropriates moneys in fund to Department of Education for distribution to counties to operate CourtCare programs.

HB 2459

Provides procedure for certain persons that hold interest in real property to request and obtain lien information statement that shows amounts necessary to satisfy encumbrance against real property from other person that holds encumbrance.

## AGENDA (Cont.) April 4, 2019

HB 2480

Creates exception to prohibition on recording communications for person who records conversation during or regarding commission of offense against person.

HB 2842

Directs Center for Health Statistics to enter name of parent on original record of live birth when paternity or parentage has been determined under certain circumstances.

HB 2932

Prohibits court from inquiring into defendant's immigration status or requiring defendant to disclose defendant's immigration status at time of plea or at any other time during criminal proceeding.

HB 3005

Modifies laws related to ignition interlock devices.

HB 3117

Extends period for filing restraining order under Family Abuse Prevention Act to two years from 180 days after date of abuse.

HB 3201

Provides that agreement for deferred resolution of criminal cases may not contain requirement that defendant enter plea of guilty or no contest.

HB 3249

Provides that client has right to privately communicate with lawyer and representative of lawyer.

HB 3337

Prohibits police officer from conducting or participating in activities intended to determine whether person has paid certain user charges, fees or tolls imposed by mass transit district.
