#### Work Session

HB 2013

Provides that person subject to certain court protective orders is prohibited from possessing firearms if person had opportunity to be heard on order and did not request hearing or withdrew request before hearing occurred.

HB 2258

Directs Office of Governor to conduct study of family treatment courts and to report results to interim committees of Legislative Assembly related to human services on or before September 15, 2020.

HB 2285

Clarifies receivership proceedings and reporting and notice requirements for residential properties that city or county determines are threat to public health, safety or welfare.

HB 2399

Authorizes court to impose compensatory fine without imposing any other fine as part of criminal sentence.

HB 2474

Excludes subpoenas issued by district attorneys for grand juries from certain notice, content and procedural requirements applicable to summonses and subpoenas issued to financial institutions for financial records of customers.

HB 2562 \*\*

Appropriates moneys from General Fund to Department of Education for Title IX enforcement and compliance, sexual harassment prevention and gender discrimination prevention.

HB 2598

Permits creation of noncharitable business purpose trust.

HB 2657 \*\*

Directs Department of Justice to administer violence prevention funding program in consultation with Attorney General's Sexual Assault Task Force.

HB 3006

Modifies procedures for probate of estate with no known assets.

HB 3007

Modifies provisions relating to small estates.

- HB 3008  
Requires approval by probate court of settlement of personal injury claim or wrongful death claim arising out of injuries to decedent.
- HB 3077  
Modifies processes relating to reporting, investigating and appealing findings related to sexual harassment in schools.
- HB 3145  
Directs Public Defense Services Commission to conduct study on improving provision of public defense services and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.
- HB 3224  
Directs district attorney of each county to, no later than December 1, 2020, develop and adopt policies relating to discovery, charging decisions and case disposition and to make policies available to public on website.
- HB 3261  
Modifies requirement to record peace officer's interview with person under 18 years of age to include interviews of investigations into misdemeanors, felonies and acts that, if committed by adult, would constitute crimes and require recorded interviews whenever person under 18 years of age would reasonably believe person is in custody.
- HB 3289  
Directs Department of Corrections to conduct study on correctional facility siting process and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.
- HB 3415  
Requires institutions of higher education to adopt written policies and conduct annual training on sexual harassment, sexual assault, domestic violence, dating violence and stalking.
- HB 3419  
Prohibits prosecuting attorney from conditioning plea offer on waiver of specified rights, eligibilities and legal challenges.

### Public Hearing and Work Session

- HB 3300  
Directs Department of Corrections to conduct study on provision of treatment services to persons in custody of department and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

### Work Session

- HB 3282  
Directs Oregon Criminal Justice Commission to conduct study on effect of prisoner reentry programs on rates of recidivism and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.  
*HB 3282 is heard for the sole purpose of referral to the House Committee on Rules without recommendation.*
- HB 3297  
Directs Oregon Criminal Justice Commission to conduct study on relationship between recidivism rates and sentence imposed and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.  
*HB 3297 is heard for the sole purpose of referral to the House Committee on Rules without recommendation.*
