- SB 495 A
 - Prohibits use of dog to extract inmate from cell in correctional facilities .
- SB 498 A

Prohibits Department of Corrections from entering into contract with inmate telephone services provider that authorizes department to receive fee or commission other than reimbursement for expenses.

SB 962 A

Directs certifying agencies to certify to United States Citizenship and Immigration Services, within specified time, victim helpfulness in detecting, investigating or prosecuting qualifying criminal activity.

SB 318 A

Permits court to order equal parenting time when developing detailed parenting plan.

SB 356

SB 474

Modifies length of time of parental desertion or abandonment of child resulting in forfeiture of parent's intestate share of child's estate and parent's interest in property transferred from child to parent by transfer on death deed.

SB 15 A

Authorizes Youth Development Division to inspect and collect data from facilities in which juveniles are detained to ensure compliance with federal Juvenile Justice and Delinquency Prevention Act.

SB 321 A

Modifies procedures by which person convicted of felony initiates proceedings to obtain DNA testing.

SB 388 A

Directs Governor or designee to notify presiding judge of circuit court of county of conviction within 10 days of granting pardon.

SB 576 A

Imposes certain requirements related to private security providers who contract with or are employed by institutions of higher education to provide private security services on campus and special campus security officers commissioned by governing boards of public universities.

SB 783 A

Modifies requirement to notify Attorney General of elder abuse proceeding, making failure to notify not jurisdictional defect.

SB 924 A

Modifies juvenile code to prohibit placement of children and wards taken into protective custody in detention facilities.
