- SB 459 A
Decreases reserve amounts in auctions for tax credits for certified Opportunity Grant contributions and certified film production development contributions.
- HB 2053 A
Modifies provisions related to employment and employee compensation for Oregon Business Retention and Expansion Program, enterprise zones, long term incentives for rural enterprise zones and business development income tax exemption.
- SB 769
Provides that request for computation of fee in lieu of property taxes for property constituting solar project may not be filed after April 1 immediately preceding property tax year to which request relates.
- SB 193 A
Extends sunset for modified method of apportionment of business income of interstate broadcaster for purposes of corporate excise taxation.
- SB 718
Expands establishment of proof of filing with Oregon Tax Court to include filing of complaint or petition dispatched via private express carrier.
- HB 2449 A
Increases rate of tax for emergency communications.
- HB 2164
Directs Legislative Revenue Officer to report to Legislative Assembly on options for tax reform including recommendations for legislation intended to reform current tax system.
- HB 2126
Directs Legislative Revenue Officer to report to Legislative Assembly on options for tax reform including recommendations for legislation intended to reform current tax system.
