Public Hearing and Possible Work Session

- HB 3431
Limits definition of "public building" or "property" to exclude convention or exposition centers, zoos, performing arts centers or other venues or attractions dedicated to tourism, travel, hospitality or entertainment for purposes of management by persons who are blind.
- SB 44
Authorizes State Board of Geologist Examiners to enter into interagency agreement with another state agency to provide for sharing of administrator.
- SB 72 A
Eliminates certain duties of Oregon Department of Administrative Services and other state agencies related to tracking and reporting of travel awards earned as part of official state business.
- SB 471 A
Requires prospective contractor to state in bid or proposal for public contract whether and extent to which prospective contractor will use conflict minerals in performing public contract and whether prospective contractor's disclosures, policies, practices and procedures with respect to procuring conflict minerals comply with Organization for Economic Cooperation and Development's Due Diligence Guidance for Responsible Supply Chains of Minerals from Conflict-Affected and High-Risk Areas.
- SB 933 A
Provides that form or document issued by public body asking person to identify person's race or ethnicity must allow person to select multiple races or ethnicities .
- SCR 26
In memoriam: Evangeline Mary Kelsch "Vange" Bigham, 1945-2018.

HB 3348

CARRIED OVER FROM THE 5-15-2019 AGENDA: Requires financial estimate committee to file statement "MEASURE SPENDS MONEY WITHOUT IDENTIFYING A FUNDING SOURCE" with Secretary of State upon finding that ballot measure with no dedicated funding source will have financial effect on public expenditures in excess of \$100,000.

HCR 33

CARRIED OVER FROM THE 5-15-2019 AGENDA: Urges Governor and state agencies to work with legislators, tribal governments, water stakeholders and others in cooperative process to create comprehensive state water vision.

SB 630

CARRIED OVER FROM THE 5-15-2019 AGENDA: Permits chairperson of county central committee or state central committee to send notification of date of anticipated meeting by postal mail or electronic mail.
