#### Public Hearing and Possible Work Session

- SB 224 A  
Removes requirement that county clerk move elector to inactive status if elector has neither voted nor updated registration for five or more years.
- SB 226 A  
Deems city to be disincorporated upon determination by Secretary of State that election on question of disincorporation was held in city in first six months of 2016, majority of voters voting on question approved disincorporation, city charter was surrendered to county in which city was situated and Department of Revenue approved map eliminating city boundaries.
- SB 998 A  
Permits person operating bicycle to enter intersection controlled by specified traffic control devices without stopping.
- SCR 37  
Recognizes and honors Keanon Lowe for his brave and selfless actions at Parkrose High School.

*The following bill is scheduled for 4:15 pm:*

- SB 761 A  
Requires that only elector who has personally printed copy, or requested that separate person print copy, of electronic signature sheet for petition or prospective petition may sign signature sheet.

#### Possible Work Session

- HB 3448  
Requires that, to extent provided by Oregon Liquor Control Commission rules, if wine labeled with American viticultural area in Oregon is labeled with single grape variety as type designation, wine must meet specified content requirements.
- HCR 38  
Establishes limitations and deadlines for legislative measures for 2020 regular session of Eightieth Legislative Assembly.
