Directs Oregon Military Department to issue grants to counties for purpose of hiring emergency management agency personnel.
- HB 2730  
Renames Office of Emergency Management as Oregon Department of Emergency Management.
- HB 2734 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs Oregon Military Department to create, fill and utilize certain positions within Office of Emergency Management.
