Public Hearing and Possible Work Session

- HB 2304 ** **Subsequent Referral(s) to Ways and Means
Authorizes issuance of lottery bonds to finance acquisition and restoration of Willamette Falls navigation canal and locks.
- HB 2591
Directs Department of Transportation to study development of uniform standards for speed bump height and markings and report on findings to interim committees of Legislative Assembly related to transportation on or before September 15, 2020.
- SB 438
Allows person issued disabled parking permit to park in parking space otherwise reserved for residents.

Work Session

- HB 2015
Eliminates requirement that person provide proof of legal presence before Department of Transportation issues noncommercial driver license, noncommercial driver permit or identification card.
- HB 2402 ** **Subsequent Referral(s) to Revenue
Increases aviation fuel taxes increased by House Bill 2075 (chapter 700, Oregon Laws 2015), and makes increases and distributions of increased revenue permanent.
- HB 2592
CARRIED OVER FROM THE 05-20-2019 MEETING: Directs Department of Transportation to study development of uniform standards for speed bump height and markings and report on findings to interim committees of Legislative Assembly related to transportation on or before September 15, 2020.
- HB 2770
CARRIED OVER FROM THE 05-20-2019 MEETING: Permits testing of highly automated vehicles on highways of this state under certain circumstances.
- HB 2881 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 05-20-2019 MEETING: Replaces vehicle weight rating with designation as passenger vehicle as qualification for per-mile road usage charge program.

- HB 3152 A
Prohibits authorized integrator, unless authorized integrator is acting in accordance with federal, state or local government law or under valid court order, from obtaining, sharing, selling, copying, transmitting, using, producing, generating or providing protected dealer data without dealer's prior express written consent or in manner that is inconsistent with dealer's prior express written consent and from locking out, deactivating or denying dealer access to dealer data system, permitting another person to obtain, share, sell, copy, transmit, use, produce, generate or provide protected dealer data without dealer's prior express written consent or charging fee for or otherwise prohibiting, preventing, restricting or limiting dealer's ownership, possession or use of protected dealer data.
- HB 3213
CARRIED OVER FROM THE 05-20-2019 MEETING: Authorizes counties to establish safety corridors and directs counties to post signs in selected safety corridors.
- SB 666
CARRIED OVER FROM THE 05-20-2019 MEETING: Increases fee for Pacific Wonderland registration plates.
- SB 1033
CARRIED OVER FROM THE 05-20-2019 MEETING: Provides that registered owner may request that registration card issued for vehicle include information that owner, or person operating vehicle, may be deaf or hard of hearing.
- SB 1044
CARRIED OVER FROM THE 05-20-2019 MEETING: Establishes goals that promote zero-emission vehicle use and requires entities of executive department to promote zero-emission vehicle use.
