SB 393

CARRIED OVER FROM THE 2/21/2019 AGENDA: Authorizes translator districts to annex cities where cable television corporations operate or have ceased operations and city electors approve annexation.

SB 227

Authorizes cemetery authority, or person with authority to determine disposition of human remains, to move, temporarily store or reinter human remains dislodged from original cemetery plot by natural disaster or other similar emergency.

SB 298

Allows employee or agent of funeral home or person acting as funeral service practitioner named in record of death or fetal death to request certified copy of record of death or fetal death at any time following date of death.

#### Public Hearing and Possible Work Session

SB 483

Requires Oregon State Lottery, in event of error, malfunction or failure that causes winnings to go unclaimed, to stop use of faulty equipment or software and attempt to pay unclaimed winnings to players.

SB 487 \*\*

Prohibits insurers from using credit history or insurance score to decline coverage of, rerate or otherwise determine eligibility for motor vehicle insurance. **\*\*Subsequent Referral(s) to Judiciary**

SB 422

Expands definition of "natural hair care" to include shampooing and conditioning.

SB 438

Allows person issued disabled parking permit to park in parking space otherwise reserved for residents.
