#### Work Session

- SB 218  
Authorizes Oregon Liquor Control Commission to refuse to issue marijuana production licenses based on market demand and other relevant factors.
- SB 365  
Prohibits local governments from imposing system development charge on projects related to production, processing or retailing of marijuana items.
- SB 585  
Directs Oregon Liquor Control Commission to establish Responsible Cannabis Retailer Program to assist marijuana retailers in maintaining compliance with cannabis laws and rules.

#### Public Hearing and Possible Work Session

- SB 827  
Allows brewery licensee or brewery-public house licensee to sell and dispense malt beverages at special event from mobile sources at nonfixed locations.
- SB 829 \*\*  
Requires that if appellation of origin on wine label is American viticultural area in Oregon that is in larger American viticultural area, label must also identify larger American viticultural area. \*\*Subsequent Referral(s) to Ways and Means
- SB 830 \*\*  
Requires that if wine labeled with American viticultural area in Oregon is labeled with single grape variety as type designation, wine must meet specified content requirements. \*\*Subsequent Referral(s) to Ways and Means
- SB 831 \*\*  
Requires that wine using American viticultural area in this state as appellation of origin or implying American viticultural area as source be produced entirely from grapes grown in that American viticultural area. \*\*Subsequent Referral(s) to Ways and Means
- SB 935  
Creates modified landscape construction professional license.
