Work Session

- SB 346
Declares policy of state to use zero-based budgeting in developing biennial budget plan.
- SB 803 **
Requires Secretary of State to establish rules authorizing licensed use of state seal on goods, wares and merchandise. **Subsequent Referral(s) to Ways and Means
- SB 585
Directs Oregon Liquor Control Commission to establish Responsible Cannabis Retailer Program to assist marijuana retailers in maintaining compliance with cannabis laws and rules.
- SB 365
Prohibits local governments from imposing system development charge on projects related to production, processing or retailing of marijuana items.
- SB 218
Authorizes Oregon Liquor Control Commission to refuse to issue marijuana production licenses based on market demand and other relevant factors.
- SB 483
Requires Oregon State Lottery, in event of error, malfunction or failure that causes winnings to go unclaimed, to stop use of faulty equipment or software and attempt to pay unclaimed winnings to players.
- SB 827
Allows brewery licensee or brewery-public house licensee to sell and dispense malt beverages at special event from mobile sources at nonfixed locations.

Public Hearing and Possible Work Session

- SB 897 **
Appropriates funds to Oregon Department of Administrative Services to distribute to State Fair Council to fund assessment of fairground facilities and deferred maintenance, improvement and enhancement of fairground facilities. **Subsequent Referral(s) to Ways and Means
- SB 108
Directs Oregon Liquor Control Commission to study liquor agent compensation for distillery tasting rooms and to report recommendations to Legislative Assembly by September 1, 2020.
