#### **Work Session**

- SB 108  
CARRIED OVER FROM THE 4/2/2019 AGENDA: Directs Oregon Liquor Control Commission to study liquor agent compensation for distillery tasting rooms and to report recommendations to Legislative Assembly by September 1, 2020.
- SB 300  
Repeals exemption from universal service fund charge for radio communications services, radio paging services, commercial mobile radio services, personal communications services and cellular communications services.
- SB 471  
Requires prospective contractor to state in bid or proposal for public contract whether and extent to which prospective contractor will use conflict minerals in performing public contract and whether prospective contractor's disclosures, policies, practices and procedures with respect to procuring conflict minerals comply with Organization for Economic Cooperation and Development's Due Diligence Guidance for Responsible Supply Chains of Minerals from Conflict-Affected and High-Risk Areas.
- SB 829 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires that if appellation of origin on wine label is American viticultural area in Oregon that is in larger American viticultural area, label must also identify larger American viticultural area.
- SB 830 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires that if wine labeled with American viticultural area in Oregon is labeled with single grape variety as type designation, wine must meet specified content requirements.
- SB 831 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires that wine using American viticultural area in this state as appellation of origin or implying American viticultural area as source be produced entirely from grapes grown in that American viticultural area.

- SB 854  
Directs professional licensing boards, in certain circumstances, to accept individual taxpayer identification number or other federally-issued identification number in lieu of Social Security number on applications for issuance or renewal of authorization to practice occupation or profession.
- SB 855  
Directs professional licensing boards to develop pathways to licensure, certification or other authorization to practice occupation or profession for specified persons.
- SB 856 \*\*  
Establishes Oregon Office of New Americans in Governor's office. \*\*Subsequent Referral(s) to Ways and Means
