#### Public Hearing and Possible Work Session

- HB 3389 A  
Provides that name and address of prize winner of certain lottery games are confidential and may not be publicly disclosed by Oregon State Lottery Commission or Oregon State Lottery unless prize winner provides written authorization for disclosure.
- HB 2415 A  
Requires that retainage be placed in interest-bearing account if contract price exceeds \$500,000.

#### Work Session

- HB 3113 A  
Increases number of premises at which winery licensee may import, process, store and export wine or cider and sell malt beverages, wine and cider under single license.
- HB 3116 A  
Requires counties with population of 650,000 or more to use proceeds from sale of foreclosed property to reimburse municipal liens against property for utilities improvements or seismic rehabilitation.
- HB 2098 A  
Directs Oregon Liquor Control Commission to establish advisory committee to advise commission, Oregon Health Authority and State Department of Agriculture on standards for testing marijuana.
- HB 2454 A  
Allows out-of-state applicant seeking occupational license in Oregon more time to meet Oregon standards if applicant is already licensed in another state and is seeking to work in Eastern Oregon Border Economic Development Region.
- HB 2312 A  
Requires seller of property to disclose whether seller has ever purchased flood insurance.
- HB 2423 A  
CARRIED OVER FROM THE 5/7/2019 AGENDA: Adopts Small Home Specialty Code to regulate construction of homes not more than 400 square feet in size.
