Public Hearing and Possible Work Session

- SB 352 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from General Fund to Oregon Department of Administrative Services for distribution to Tucker Maxon School to provide financial aid to students with hearing loss who cannot afford tuition and for capital improvements.
- SB 777 ** **Subsequent Referral(s) to Ways and Means
Establishes Task Force on Prison Education.
- SB 949 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to Higher Education Coordinating Commission for purposes of prison education programs.
- SB 786 ** **Subsequent Referral(s) to Student Success then to Ways and Means
Directs school district board to adopt child sexual abuse prevention instructional program that addresses sex trafficking of children.
- SB 1017 ** **Subsequent Referral(s) to Ways and Means
Requires State Fire Marshal to adopt rules establishing minimum standards for carbon monoxide alarms in school facilities that have carbon monoxide source.

Work Session

- SB 312 ** **Subsequent Referral(s) to Ways and Means
Requires public universities and community colleges to charge resident tuition to Native Americans and Alaska Natives who graduated from Oregon high schools.
- SB 692 ** **Subsequent Referral(s) to Student Success then to Ways and Means
Directs Youth Development Division to develop and administer statewide youth reengagement system.
- SB 852 ** **Subsequent Referral(s) to Ways and Means
Provides that part-time faculty member at public institution of higher education who qualifies for health care benefits will pay 10 percent of insurance premiums, with remaining 90 percent paid by state.
- SB 730
