Public Hearing and Possible Work Session

- SB 455 ** **Subsequent Referral(s) to Ways and Means
Requires public universities, community colleges and community college districts to require contractors to employ apprentices and to establish and execute plan for outreach, recruitment and retention of women and minority individuals for certain work relating to improvements to real property.
- SB 800 ** **Subsequent Referral(s) to Student Success then to Ways and Means
Directs Higher Education Coordinating Commission to develop standards for partnership based in high school for purpose of providing dual credit program.
- SB 844 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to Higher Education Coordinating Commission for 2019-2021 biennium for use by Oregon State University to develop, implement and operate website for providing public with information related to plant pest solutions.

Work Session

- SB 155 ** **Subsequent Referral(s) to Judiciary
Requires all investigations involving suspected abuse or sexual conduct by school employees to be conducted by Teacher Standards and Practices Commission.
- SB 158
Directs Higher Education Coordinating Commission to develop and implement pilot program to assist foster youth transitioning from community colleges to public universities.
- SB 159
Directs Higher Education Coordinating Commission to establish foster youth success centers in each public university.
- SB 428
Directs Secretary of State to conduct audit of use of statewide summative assessment in public schools in this state.
- SB 496
Requires school districts to ensure that all students of school district have equal access to educational facilities.
- SB 497
Lowers high school grade point average required to participate in Oregon Promise program from 2.5 to 2.0.

- SB 719 ** **Subsequent Referral(s) to Student Success then to Ways and Means
Directs Department of Education to conduct evaluation and administer pilot program related to abbreviated school day programs.
- SB 731
Authorizes recognized student government of community college or public university, or member of recognized student government, to make statement or issue resolution to promote or oppose gathering of signatures on initiative or referendum petition or adoption of ballot measure.
- SB 859 ** **Subsequent Referral(s) to Ways and Means
Exempts graduate students at public universities who qualify for tuition equity from having to pay nonresident tuition.
- SB 958 ** **Subsequent Referral(s) to Ways and Means
Establishes Dreamers Access Program to award student loans to eligible students with demonstrated financial need.
