Requires district school board or hearings officer to conduct hearing in executive session or privately if hearing pertains to or involves examination of confidential records of student.

HB 2871 A

Renames Oregon Youth Conservation Corps as Oregon Youth Corps.

HB 2213 A

Requires each community college and public university to establish textbook affordability plan.

HB 2216

Repeals sunset date on temporary law and makes permanent law requiring public universities to interview qualified minority candidate when hiring head coach.

HB 2263 A

Directs Department of Education, in collaboration with Higher Education Coordinating Commission, to administer Accelerated College Credit Planning Partnership Grant Program to encourage partnerships between school districts and post-secondary institutions of education to offer accelerated college credit programs.

HB 2457 A

Directs Teacher Standards and Practices Commission, Department of Education and Office of Child Care to make specified evaluations to increase number of educators in Eastern Oregon Border Economic Development Region who are available to teach courses in secondary math and science and in career and technical education programs.
