#### **Public Hearing**

SB 93

Provides that beverage container redemption centers are not recycling depots for purposes of certain recycling laws. SB 522

Prohibits person from intentionally returning for refund value during one day 25 or more individual beverage containers that person knows or has good reason to know were not sold in this state.

SB 892

Exempts containers that contain certain oral rehydration products from bottle bill provisions.

#### Work Session

SB 98

Requires Public Utility Commission to adopt by rule renewable natural gas program for natural gas utilities to recover prudently incurred qualified investments in meeting certain targets for including renewable natural gas in gas purchases for distribution to retail natural gas customers.

SB 884 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Authorizes qualified institutions to receive loans from Water Pollution Control Revolving Fund to finance projects to repair or replace failing on-site septic systems or to replace failing on-site septic systems with connections to available sewer.

SB 914

Requires certain distributors and importers to register with distributor cooperatives and provide certain information to distributor cooperatives.

HB 2086 A

Revises definitions and harmonizes language for purposes of program supporting working land conservation.
