Work Session

- HB 2106 A
CARRIED OVER FROM THE 5/21/2019 AGENDA: Allows dog training classes to be conducted in farm buildings existing on January 1, 2019, within counties that adopted marginal lands provisions.
- HB 2109
CARRIED OVER FROM THE 5/21/2019 AGENDA: Requires that, in election proposing annexation, votes from city and territory to be annexed be counted separately to determine separate majorities if territory to be annexed includes 100 acres or more.
- HB 2225 A
CARRIED OVER FROM THE 5/21/2019 AGENDA: Defines "center of the subject tract" for siting certain permissible forest dwellings.
- HB 2573 A
CARRIED OVER FROM THE 5/21/2019 AGENDA: Requires counties to approve establishment of dwellings in conjunction with farm use on high-value farmland for cranberry farm operator meeting \$40,000 annual income standard.
- HB 2841 A
CARRIED OVER FROM THE 5/21/2019 AGENDA: Allows State Department of Fish and Wildlife to refuse disclosure of information relevant to department ability to manage or protect described fish or wildlife species or individual members or populations of species.
- HB 2883 A
CARRIED OVER FROM THE 5/21/2019 AGENDA: Prohibits food vendor from using polystyrene container in selling, offering for sale, serving or dispensing prepared food to public.
- HB 3024
CARRIED OVER FROM THE 5/21/2019 AGENDA: Prohibits county from considering property tax classification of dwellings that were previously removed, destroyed, demolished or converted to nonresidential uses when reviewing application for replacement dwelling on lands zoned for exclusive farm use.

HB 3272 A

CARRIED OVER FROM THE 5/21/2019 AGENDA: Limits extension that Land Use Board of Appeals may provide petitioner whose objection to record is denied to 14 days from later of original deadline or date of denial.

HB 3365

CARRIED OVER FROM THE 5/21/2019 AGENDA: Changes process for forming or dissolving livestock district, annexing land to livestock district or withdrawing land from livestock district.
