SB 971

Directs Commission on Indian Services to study tribes.

SB 972

Directs Oregon Law Commission to review and recommend improvements to laws related to liens.

SB 975

Directs Oregon Criminal Justice Commission to conduct study on effect of prisoner reentry programs on rates of recidivism and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 976

Directs Oregon Criminal Justice Commission to conduct study on effect of participation in specialty courts on rates of recidivism and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 977

Directs State Court Administrator to study issues relating to courts and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

SB 979

Directs Department of State Police to conduct study on prosecution of crime of unlawfully purchasing a firearm and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 980

Directs Department of Corrections to conduct study on provision of treatment services to persons in custody of department and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 981

Directs Oregon Youth Authority to study and make recommendations on provisions of state law relating to operation and procedures of Oregon Youth Authority.

SB 982

Directs Department of Corrections to study sex offenders.

SB 983

Directs Oregon State Bar to study issues relating to evidence and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

SB 984

Directs Department of Justice to study law enforcement officers.

SB 985

Directs State Court Administrator to study issues relating to court fees and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

SB 986

Directs Oregon Criminal Justice Commission to conduct study on relationship between recidivism rates and amount of fines imposed and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 987

Directs State Court Administrator to study issues relating to courthouses and report to committee of Legislative Assembly no later than December 31, 2020.

SB 988

Directs Oregon Criminal Justice Commission to conduct study on relationship between recidivism rates and payment of restitution and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 989

Directs Department of Justice to study post-conviction relief.

SB 990

Directs Department of Corrections to conduct study on correctional facility siting process and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 991

Directs Oregon Criminal Justice Commission to study convictions.

SB 993

Directs Department of Justice to study and make recommendations on provisions of state law relating to child custody.

SB 995

Directs State Court Administrator to study issues relating to civil proceedings and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

SB 997

Directs Oregon Criminal Justice Commission to conduct study on relationship between recidivism rates and payment of restitution and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 998

Directs State Court Administrator to study violations.

SB 999

Deletes obsolete reference to definition of "alternative fuel vehicle." Defines "alternative fuel vehicle.".

SB 1000

Directs Oregon Criminal Justice Commission to conduct study on pretrial release and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 1001

Directs State Court Administrator to study issues relating to court records and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

SB 1002

Directs Oregon Criminal Justice Commission to conduct study on relationship between recidivism rates and length of prison sentences and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 1003

Directs State Court Administrator to study issues relating to small claims and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

SB 1004

Directs Department of Justice to conduct study on prosecution of domestic violence offenses and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 1005

Directs Oregon Criminal Justice Commission to conduct study on relationship between recidivism rates and sentence imposed and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 1006

Directs State Court Administrator to study issues relating to juries and report to committee or interim committee of Legislative Assembly no later than December 31, 2020.

#### Work Session

SB 24

Modifies procedures related to criminal defendants lacking fitness to proceed.

SB 111

Provides that wine meeting certain criteria is deceptively labeled or branded.

SB 299

Prohibits denial of medical assistance on basis that individual under 18 years of age is in detention pending adjudication.

SB 321

Modifies procedures by which person convicted of felony initiates proceedings to obtain DNA testing.

SB 369

Modifies statute of limitation for action against architect, landscape architect or engineer arising out of construction, alteration or repair of improvement to real property.

SB 379

Provides that conditioning employment on refraining from using any substance that is lawful to use in this state is unlawful employment practice.

SB 380

Prohibits county from bringing claim or action against person if claim or action is based on statement in trust deed that nominee or agent of lender is grantee or beneficiary, based on county's recording or indexing instrument that states that nominee or agent of lender is grantee or beneficiary or based on person's having obtained or transferred interest in trust deed by means of instrument that was executed or delivered to person but was not recorded in county's deeds and mortgages records or in county's County Clerk Lien Record.

SB 420

Directs Department of Justice to identify misdemeanor convictions for possession, delivery or manufacture of marijuana based on conduct that would not constitute crime under current law.

SB 482

Provides that sexual assault restraining order is of indefinite duration and continues until order is terminated by court.

SB 576

Imposes certain requirements related to private security providers who contract with institutions of higher education to provide private security services on campus and special campus security officers commissioned by governing boards of public universities.

SB 579

Creates exception under Death with Dignity Act to 15-day waiting period for patient with less than 15 days to live.

SB 591

Makes violation of statutes or rules regarding minimum standards for wine, or branding or labeling requirements for wine, unlawful trade practice.

SB 685

Renames Law Enforcement Contacts Policy and Data Review Committee to Commission on Equity in Policing.

SB 703

Prohibits commercial sale of health information by covered entity, business associate, subcontractor, as defined by Health Insurance Portability and Accountability Act of 1996, or other third party, without authorization of individual whose health information would be included in sale.

SB 723

Prohibits person from organizing, sponsoring, promoting, conducting or participating in contest, competition, tournament or derby that has objective of taking wildlife for prizes or other inducement or for entertainment.

SB 725 \*\*

\*\*Subsequence Specifies charges or convictions that may not be considered in fitness determinations.

SB 763

Defines "dangerous to self or others" for purposes of civil commitment proceedings.

SB 775

Requires public bodies to use Department of State Police for purposes of requesting criminal records checks relating to employment by public body.

SB 810

Modifies definition of "vulnerable user of a public way" to include persons operating or riding on moped or motorcycle.

SB 873

Allows defendant in eviction action to apply for order setting aside judgment.

SB 912 \*\*

Revises definition of terms "sexual conduct" and "substantiated report" for purposes of certain laws related to abuse and sexual conduct by school employees.

SB 924 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Modifies juvenile code to prohibit placement of children and wards taken into protective custody in detention facilities.

SB 966

Provides that person in custody of Oregon Youth Authority for offense committed while person was under 18 years of age, for which person was sentenced to term of imprisonment with projected release date that falls after person attains 25 years of age but before person attains 27 years of age, is eligible for conditional release hearing.

SB 967

Requires court to include in judgment document age of defendant at time of committing offense if defendant sentenced to term of incarceration and physical custody of defendant is related to age of defendant at time of committing crime.

SB 968

Prohibits person who was under 18 years of age at time of committing offense from being sentenced to life imprisonment without possibility of release or parole.

SB 973

Requires Oregon Health Authority to research, study and compare behavioral health treatments in other states and report findings and conclusions to interim judiciary committees of Legislative Assembly no later than September 20, 2020.

SB 969

Eliminates mandatory adult prosecution for certain offenses committed when person charged is 15, 16 or 17 years of age at time of offense.

SB 978

Directs Department of State Police to conduct study on reporting of attempted unlawful firearm transfers and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

SB 1008

Authorizes juvenile offender charged with offense subject to mandatory minimum sentence, who receives mandatory minimum sentence or other sentence of imprisonment, to be eligible for conditional release after serving at least one-half of sentence imposed.

SB 1013

Removes future dangerousness as factor for jury to determine when deciding on sentence of death.

SB 1040

Makes owner, operator or lessee of quarry or mine located on property adjacent to Willamette River in Polk County strictly liable for injuries resulting from bullets that stray outside boundaries of property.
