The following bill is scheduled for a Possible Reconsideration and Work Session to allow the committee to consider the fiscal and revenue impact statements.

#### **Possible Reconsideration and Work Session**

SB 750 \*\* \*\*Subsequent Referral(s) to Judiciary then to Ways and Means Establishes procedure for aggrieved person, whistleblower or representative organization to bring action in name of state to recover civil penalties for violations of certain laws related to labor and employment.

#### Work Session

SB 768 \*\* \*\*Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 4/4/2019 AGENDA: Exempts retired member of Public Employees Retirement System from limitations on reemployment if member is reemployed as teacher by school district or education service district.

SB 726

CARRIED OVER FROM THE 4/4/2019 AGENDA: Makes unlawful employment practice for employer to request employee to enter agreement that would prevent employee from disclosing or discussing conduct that constitutes unlawful discrimination, including sexual assault.

SB 479

CARRIED OVER FROM THE 4/4/2019 AGENDA: Requires public employers to adopt policies to prevent workplace harassment.

SB 478

CARRIED OVER FROM THE 4/4/2019 AGENDA: Prohibits campaign moneys and public moneys from being used to make payments in connection with nondisclosure agreement relating to harassment in workplace. SB 1026

CARRIED OVER FROM THE 4/4/2019 AGENDA: Requires employers of seafood processors to calculate applicable overtime pay for employees on daily and weekly basis and pay greater of two amounts.
