SB 1026

CARRIED OVER FROM THE 4/4/2019 AGENDA: Requires employers of seafood processors to calculate applicable overtime pay for employees on daily and weekly basis and pay greater of two amounts.

SB 123

CARRIED OVER FROM THE 4/4/2019 AGENDA: Extends application of provision prohibiting salary history inquiries to include employment agencies.

SB 479
