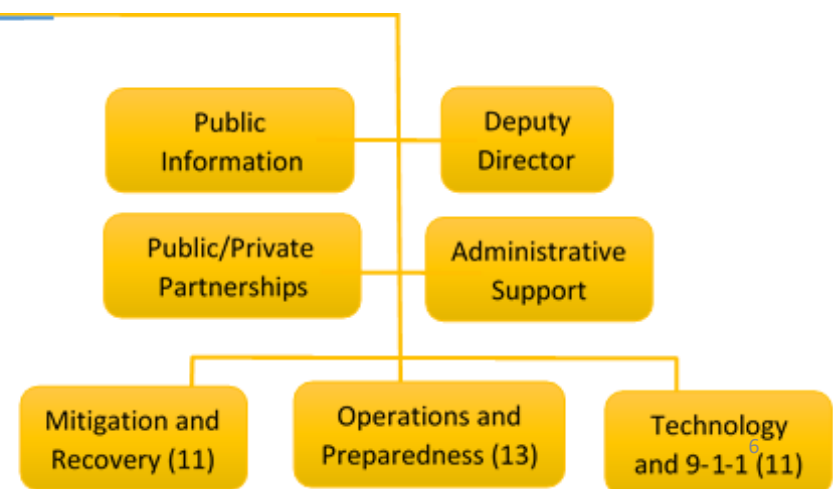


# State Emergency Management Structure



- The Adjutant General serves as the Governor's Homeland Security Advisor
- The OEM Director is the liaison from the ECC to the Governor's Disaster Cabinet
- ORS 401, 402, and 403

- The Dual Status Commander(s) commands/coordinates federal military response within the state

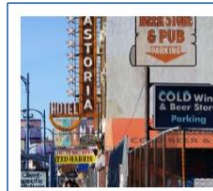

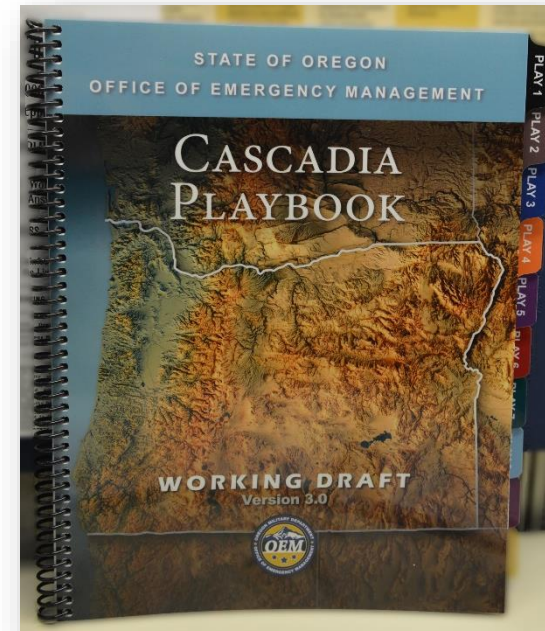

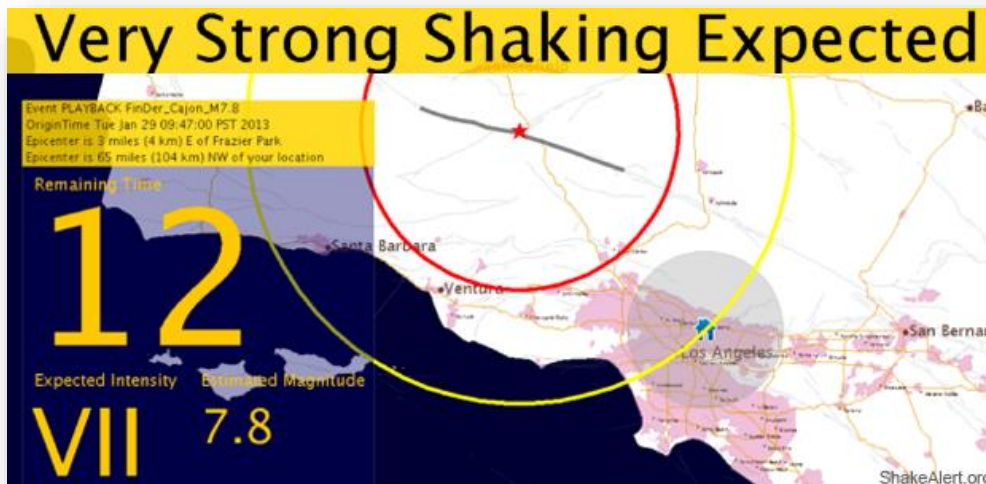

# Citizen Corps Programs (?)

- A Federal Program, Which Includes:
  - Community Emergency Response Teams (CERT)
  - Medical Reserve Corps (MRC)
  - Fire Corps
  - Neighborhood Watch
  - Volunteers in Police Service (VIPS)
- CCP Grant Program ended following FY 2011 awards
- FY 17 HSGP: \$76k
- FY 18 HSGP: \$116k
- Citizen Corps in Oregon







# HB 2687/ The SPIRE Grant Program (?)

---

- Application Period opened 8 JAN 2019
- Application Period closes 1 MAR 2019
- Peer Review Committee will review applications in March/April
- Applicants will receive notification NLT 30 MAY 2019
- Grantees will receive sub-grant NLT 31 AUG 2019
- 3-page grant application encourages regional collaboration
- Authorizes applicants to request resources from a list of 15 categories to meet state response priorities
- OMD/OEM will procure the equipment awarded following the bond sale (13 FEB 19) and availability of funds.
